1. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 2. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

3. Generic

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

1. Technical eligibility of bidders :-

(a) The Bogie wheels may be purchased from:

(i) OEM of the bogie wheel presently used in Lucknow Metro rolling stock, namely Jupiter Tatavag onka Railwheel Factory Pvt. Ltd. (formerly Bonatrans India Private Limited); or

(ii) Any OEM manufacturing forged bogie wheels; or

(iii) Any authorised distributor or authorised service partner of the entities above.

(b) The bidder shall submit, along with the bid, duly signed and stamped copies of the following documents pertaining to the offered product, demonstrating compliance with the technical specifications and requirements stipulated in section 5 of the specification document attached in the bid, for the evaluation of compatibility and suitability by UPMRC:

(i) Technical Data Sheet; and

(ii) Technical Drawings.

(c) For Bidders falling under category (a)(ii), including their authorised distributors/service partners, documentary evidence (purchase order, invoice, and/or proof of payment) shall be submitted establishing compliance with the following eligibility criteria:

(i) The bidder shall have prior experience in the supply of same or similar items to any Metro or Railways in India. During the last seven (07) years ending on the last day of the month immediately preceding the month in which the tender is floated, the bidder shall have successfully executed supply orders and/or received purchase orders for same or similar items satisfying any one of the following criteria:

(1) Three (03) orders, each for a quantity not less than sixty (60) units (40% of the tendered quantity); or

(2) Two (02) orders, each for a quantity not less than seventy-five (75) units (50% of the tendered quantity); or

(3) One (01) order for a quantity not less than one hundred and twenty (120) units (80% of the tendered quantity).

For the purpose of this clause, "same or similar items" shall mean forged steel wheels.

(d) The successful bidder must submit the final test report of the wheels being supplied at the time of delivery. Acceptance of the material shall be subject to conformance of the test report with the specifications outlined in Section 5.1 of the Specification Document attached to the bid.

2. Warranty:-The warranty period shall be a minimum of twelve (12) months from the date of acceptance of the supplied lot. During the warranty period, notwithstanding anything contained hereinabove, UPMRC reserves the right to conduct random sample testing of the supplied products at any stage and from any category of bidder.

If any sample from the supplied lot fails to meet the applicable Acceptance Tests and/or specification requirements, UPMRC shall invoke the warranty provisions and require replacement of the failed product(s). The decision of UPMRC in this regard shall be final, conclusive, and binding upon the Contractor.

3. F.O.R destination:- Firm shall deliver the materials at Workshop, Transport Nagar Metro Depot, Lucknow, UP-226012, Contact No. 9696102180.

4. Payment:- a) 100% payment will be done within 45 days after receipt & acceptance of the material in sound condition by the consignee.

b) GST amount will be released only after the invoice has been reflected in GST-2B of UP Metro and vendor has paid GST amount and filed GSTR-3B for the same.

5. Performance Bank Guarantee:- Bank Guarantee (in original) of the 5% of the total contract value must be submitted after the successful award of the contract within 30 days. Performance security may be furnished in the form of original bank guarantee, demand draft, fixed deposit or may be directly deposited into UPMRC bank account. It shall be released after successful completion of warranty period.

Note:- Bidders may please note that GeM is capturing and showing the IP addresses used by the bidders and buyers. The received bids having matching/common IP address with either bidders/buyer, shall be out-

ghtly rejected & shall not be considered for further evaluation.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. 9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.
