2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Buyer Added Bid Specific ATC

K. EVALUATION METHODOLOGY:

- Price bid shall be evaluated on overall L1 basis (including GST) and order will be placed on the overall lowest cost (L1) basis. Bidder must quote all the items of SOR, failing which bid shall be rejected.
- Purchase preference as per Public Procurement Policy-2012 (PPP)/PP P-MII shall be applicable considering tendered items as split table as per distribution given below.

However, benefits of Public Procurement Policy-2012 (PPP) shall be applicable for manufacturer/assembler/packager of CNG Storage Cacades or manufacturer of CNG Cylinders.

- 3 GAIL Gas intends to distribute the tendered scope of work among Four (4) techno-commercially acceptable bidders. Methodology of Award of Work: GAIL Gas intends to distribute the entire scope, as per details below.

Notes:

- a) All the bidders shall be asked to confirm matching their price with L1 bidder in a single step, irrespective of their ranks to save time and order shall be placed among the bidder(s) (subject to matching of L1 price), as per the distribution of quantities mentioned above. Matching with L1 Price is to be done by way of uniform percentage reduction on respective bidder's quoted price.

The order of allocation of quantities among bidders (except in case of applicability of purchase preference (PPP, 2012 & PPP-MII), when preferred bidder shall have priority over other bidders) on matching L1 price shall be in sequence of their inter-se position (L1, L2, L3... and so on).

- b) In case purchaser preference (PPP, 2012 & PPP-MII) is applicable as per condition given in tender, the distribution as given above shall be changed to the extent of providing the preference as per the conditions. The quantities to be provided to preferential bidder will be taken out from allocation of 'Non MSE & class II local supplier bidders' in reverse order of their ranking [i.e. first qty. shall be taken out from L3, then from L2 (if requiredand so on)].

- c) In case requisite number of qualified bidder(s) (i.e. L2, L3, L4.... L n) are not available/ not agreeing to match the L1 price for award of complete scope of tendered work, re-distribution of the balance quantity will be done in equal proportion among the techno-commercially acceptable L1 bidder and bidders matching the L1 price. Bidder is required to submit the undertaking in this regard in the prescribed format of tender document alongwith un-priced bid.
- d) Award of quantity more than prescribed quantity (i.e. 84 numbers for 3000 WL Capacity Cascade) shall be subject to bidder(s) meeting BEC for quantum being considered for award. Bidder is required to submit the undertaking in this regard in the prescribed format of tender document alongwith un-priced bid. The quantum so left over shall also be distributed equally among the other bidder(s). In doing the above exercise, it may so happen that the quantity % indicated at Table No. 1 above may get changed including maximum quantity to be awarded to original L1. While distributing, quantities shall be rounded off suitably (wherever required) and the decision of GAIL Gas shall be final in this regard.
- e) In the event that none of the other bidders agree to match the L1 price, the entire quantity (**210 Nos.**) may be awarded to the L1 bidder, subject to the bidder meeting the BEC requirements for **100% of the tendered scope**

- h) The evaluated price of bidders shall include the following:
- i. Ex-works price with GST quoted by the bidder (including packing, forwarding, and GST on components and raw materials but excluding Inland Transportation to Delivery Location) including cost of Inspection by Third Party Agency, mandatory spares etc. (wherever applicable) -of Cascades.
 - ii. Inland transportation price with GST upto Delivery location and other costs incidental to delivery of goods- For cascade 3000 WL
 - iii. Charges for incidental services, if any as per MR/ SOR, and GST (CGST & SGST/UTGST or IGST) on these services.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. 8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

- All operative provisions of the erstwhile Labour Laws until their complete substitution.

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
