1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
3. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 30% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.
6. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Certificates

3. OEM

4. Certificates

5. Warranty

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. TERMS AND CONDITION & TECHNICAL SPECIFICATION: -

1) Rates/Price: -

The quoted rate shall be of inclusive of all taxes, duties etc. Nothing shall be paid extra. Rate shall remain valid to be quoted for a period of 6 month from the date of the tender.

2) **Consignee: -** Executive Engineer PHE Division Kargil.

3) **Excise Duty: -**All taxes/duties shall be included in the above quoted rates. No extra claim on this a/c shall be entertained by the department.

4) Terms and Payments: -

90% (Ninety Percent) Payment along with 100% taxes shall be paid subject to availability of fund against delivery of material in accordance with specifications and terms and condition of the supply order, in stores of PHE Division and verification thereof as well as subject to production of satisfactory inspection note from the third-party inspection agency along with dispatch document and execution of agreement with the department. Balance 10% (ten percent) amount of the payment shall be released after successful completion of the contract in all respects and verification thereof. Any claim of interest on account of payment shall not be entertained.

5. Marking: -

Each packing shall bear the marking, name of product, lot no and date of manufacture, expiry date, manufacturer and capacity of each pack.

6. Security Deposit: -

In addition to 2% earnest money the successful tenderers/firm is required to deposit an amount equivalent to 2% total value of the contract as security in the shape of CDR of any schedule Bank pledged to the Superintending Engineer PWD Circle Kargil.

7. Inspection:-

The firm shall furnish manufacturers test certificate in triplicate duly authenticated by the manufacturers under proper seal and signature and the material shall be inspected by the representative of the department.

8. Verification: -

Bill/ claims against the supplier made by the firm shall have to be verified by Concerned Assistant Executive Engineer in charge store, Assistant Executive Engineer will ensure it, and of the store, that materials are received in store as per specification & terms and condition laid by the department.

9. Paying authority: -

Executive Engineer PHE Division Kargil on production of bills and verification of material received.

10. Transit Risk: -

The material shall be transported to divisional store of consignee Baroo at Kargil duly insured by the supplier against transit risk. It shall be the responsibility of the supplier to ensure safe delivery/stacking of material in the consignee's store. Only perfect, sound and un-damaged material accompanied with test certificate furnished by authorized testing agency shall be accepted in the store.

11. Guarantee/warranty: -

The firms shall furnish a declaration that the materials supplied is of the best quality and the workmanship and strictly in accordance with the specification mentioned in the supply order. **The firm shall furnish a manufacturer's test certificate with every lot.** The firm shall further furnish a declaration /guarantee that the materials would conform to the description quality as mentioned for a period of 18 months from the date of delivery of the material. If within a month from the date of use, notwithstanding the fact that the inspector may have inspected or approved the material during the aforesaid period the same material be discovered not to specification of supply order, the decision of the Superintending Engineer PWD Circle Kargil in that behalf shall be final and conclusive. The department will be entitled to reject said material at the risk of the firm, the firm shall, if so called upon to replace the rejected materials, will replace within a period of one month. In such an event the above-mentioned guarantee period shall apply to the materials replaced from the date of replacement thereof, otherwise the firm shall pay the department such damages as may result out of reason of the breach of the condition herein.

12. **Penalty:-**(a) In the event of firms failing, delaying the supplies in time and also in the event of any damages occurring or being caused by the firm to the goods supplied and also for not complying with any of the terms and conditions specified in the contract, the department shall with or without prejudice to any remedy available to under any law in force in the state at that time.

a) Recover the amount of loss caused by damage, failure or default by the firm, as may be determined by the department and/or.

b) Impose penalty up to 20% of the value and for of contract as determined by the District Superintending Engineer and or forfeit the security and /or.

c) Forfeit the security and /or/Bank Guarantee and/or.

d) Terminate the contract after 30 day's notice.

13. Indemnity Bond: -

The successful firm shall furnish an indemnity bond on non-judicial stamped paper for the total value of the order valid for guarantee period, guarantee towards the following.

- a) Satisfactory completion of the order.
- b) Satisfactory working/performance of the equipment's.
- c) An undertaking regarding refund to the department in respect of the said order on account of payment in advance for supply of stores not being in accordance with the specifications and conditions of the order.

14) Duration and place of delivery: -

The material should be delivered within 25 days from the date of placement of supply order, FOR at site.

15) Agreement: -As soon as supply order is communicated to the firm, the contract shall become complete and binding upon them, the firm shall also be required to execute an agreement with the department (three blank agreement forms and enclosed herewith) within seven days from the date of issue of this order which may please be returned to this office duly filled up signed and sealed by the prop. or any other authorized officer of the firm attested by two persons and attested by the Notary. Three copies of the supply order signed by the prop. or any other authorized officer of the firm in token of acceptance of supply order should also accompany the agreement. Failure to execute such an agreement in time shall not however, prevent this contract from the date of issue of this supply order.

16) Arbitration: -

If at any time, any question, dispute or difference whatsoever shall arise between the parties upon or in relation to or in connection with the contract, either of the parties may give the other notice in writing of the existence of such a question, dispute or difference and the same shall be referred to award to two Arbitrators, one to be nominated by the Department and the other by the approved supplier. In case of such Arbitrators not agreeing then award of an Umpire to be appointed by the Arbitrators in writing before proceedings with the reference and the decision of the Arbitrators or in the event of not agreeing of the Umpire appointed by them shall be final and binding on the parties, such a notice of the existence of any question or dispute or difference in connection with the contract shall be served by either party within 45 (Forty Five) days of difference failing which all rights and claims under this contract shall be deemed to have been forfeited and shall be barred upon every or any such reference the cost of incidentals of the reference and award respectively shall be at the discretion of the Arbitrator and in the event of their not agreeing of the Umpire appointed by them who may determine the amount thereof or direct the same fixed between party and party shall direct by whom to whom and in what manner the same shall be formed and paid. The revision of the J&K Arbitrations Act Samvat 2002 and of the rules there under the statutory modification where of shall be deemed to apply to the arbitration, dispute, if any regarding reference to court shall be subject to the jurisdiction of J&K Courts only.
