1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any

purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE 25% : The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 25 percent with the consent of the service provider

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

4. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

5. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

6. Forms of EMD and PBG

Bidders can also submit the EMD with Fixed Deposit Receipt made out or pledged in the name of A/C

. The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. has to upload scanned copy/ proof of the FDR along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date/ Bid Opening date

7. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Fixed Deposit Receipt also (besides PBG which is allowed as per GeM GTC). FDR should be made out or pledged in the name of

A/C (Name of the Seller). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of Security Deposit, the FDR will be released in favour of bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Successful Bidder has to upload scanned copy of the FDR document in place of PBG and has to ensure delivery of hard copy of Original FDR to the Buyer within 15 days of award of contract.

8. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

I) This bid shall be evaluated and governed by latest GCC for services-2018 and Dy.GM(G)/SCR Vehicle Hiring Guidelines issued on dt:13.03.2024 and as per the latest instructions from Railway Board/SCoR HQRS.

II) The bidder should submit the List of Ongoing Contracts with Railways, Other Central Government Departments, State Government and PSUs in the attached proforma **Annexure- II. Non-Submission of this statement even if NIL, in Annexure- II shall lead to summary rejection of offer.**

III) The bidder should submit an Undertaking along with the bid that he/she is not under liquidation, court receivership or similar proceedings and not bankruptcy in the attached proforma **Annexure-III. Non-submission of duly filled Annexure- III shall lead to summary rejection of offer.**

IV) The offered Vehicle/s as per submitted documents against this bid, should not be currently engaged in any ongoing contract of Centre/State Govt. organization with contract period overlapping with the contract period in the current bid. Self-declaration certifying the same in the attached proforma **Annexure-T** must be submitted along with the bid. **Non-submission of duly filled Annexure-T shall lead to summary rejection of offer.**

V) Formats of Annexures is uploaded in "Buyer uploaded ATC document" under "Buyer Added Bid Specific ATC".

VI) The documents uploaded shall be self-attested consisting of signature, stamp of the authorized person participating in the bid. Otherwise, such document shall not be considered at the time of evaluation and offer will be **SUMMARILY REJECTED.**

VII) The vehicle should be made available (24 X 7) in the nominated RAILWAY PREMISES as decided by the Officer-in-charge.

VIII) Geographical presence must be located in the state of ANDHRA PRADESH STATE and documentary evidence to be uploaded along with the offer. The offers, which will be received other than locations of ANDHRA PRADESH STATE will not be considered. Further, no correspondence will be considered.

IX) Technical Bid: Shall consist of

i. Tender Security Amount/Earnest Money Deposit (EMD).

ii. Documents in support of fulfilment of the laid down ELIGIBILITY CRITERION as per "Buyer uploaded ATC document" under "Buyer Added Bid Specific ATC".

iii. Documents in support of fulfilment of the laid down ELIGIBILITY CRITERION shall also include as under.

1.0 Minimum Eligibility Criteria

(a) Work Experience: The bidder should have satisfactorily completed* in the last three previous financial years and the current financial year up to the date of opening of the tender, one similar single contract work for a minimum of 35 %of the advertised value of the bid.

Similar Nature of work means- "Supply / Providing of Road vehicles for transportation of men/ material to Central/ State Government departments or Central/state Government Public sector undertakings"

* Completed contract includes on-going service contract subject to payment of bills amounting to at least 35 % of the advertised value of the bid. **Tenderer has to produce supporting documents/Experience certificates as per the format mentioned in Annexure-E.**

Note: The bidder shall submit details of work executed by them in the prescribed format along with bid for the service contracts to be considered for qualification of work experience criteria clearly indicating the nature/scope of contract, actual completion cost and actual date of completion for such contract.

Work experience certificate from private individual shall not be accepted. Certificate from public listed company/private company/Trusts having annual turnover of Rs.500 crore and above subject to the same being issued from their Head office by a person of the company duly enclosing his authorization by the Management for issuing such credentials. The offer of the bidder who does not enclose experience certificates duly fulfilling the above conditions will be summarily rejected.

(b) Financial Standing: The tenderers will be qualified only if they have minimum financial capabilities as below: -

(i) **T1- Financial Turnover:** The bidder should have a contractual amount not less than 1.5 times the advertised Bid value during the last three previous financial years and in the current financial year up to the date of opening of the tender.

The audited Balance sheet reflecting contractual receipts certified by Chartered Accountant with her/his stamp, signature and membership number for the completed financial years shall be considered.

(a) Audited Balance Sheets clearly indicating financial turnover and Profit & Loss statement for the completed Financial Years should also be submitted supported with Financial turnover certificate (**Annexure-F**) issued by Chartered Accountant.

(b) For the current financial year, Provisional Balance Sheet issued by Chartered Accountant, clearly indicating contractual receipts supported by Income Tax Form-26AS, shall be considered. The offer of the bidder who do not enclose certificates duly fulfilling the above conditions will be summarily rejected.

NOTE:

i. Financial Year shall normally be reckoned as 1 st April to 31 st March of the Next Year. However, for Turnover Criteria, the Financial Year as applicable to the Company/Tenderer is to be considered, if it defers from the above.

ii. Current Financial Year is reckoned as the incomplete Financial Year in which the date of tender submission falls.

iii. Chartered Accountant statements duly indicating yearly receipts will not be considered until and unless backed by Audited Balance Sheets or Provisional Balance Sheet with 26AS statement of Income Tax Department.

If the tender is not accompanied by the certificate(s) in support of financial eligibility as above, the tender shall be rejected. No post-tender correspondence will be entertained.

(ii) **T2-Liquidity:** The bidder should have access to or has available liquid assets, lines of credit and other financial means to meet cash flow that is valued at 5% of the estimated bid value net of applicant's commitments for other contracts. The latest audited balance sheet certified by chartered accountant with his/her stamp, signature and membership number and/or banking reference shall be submitted by the bidder along with bid.

Banking reference should contain in clear terms the amount that bank will be in a position to lend for this work to the applicant/member of the Joint Venture/Consortium. In case the Net Current Assets (as seen from the Balance Sheets) are negative, only the Banking references will be considered. Otherwise, the aggregate of the Net Current Assets and submitted Banking references will be considered for working out the Liquidity. Otherwise, the aggregate of the net current assets and submitted banking reference will be considered for working out the liquidity, **Annexure-P**.

The banking reference should be from a Scheduled Bank in India and it should not be more than 3 months old as on date of submission of bids. Please refer **Annexure-O** for sample format for banking reference for

liquidity. In case of JV firms' overall liquidity of JV firm shall be assessed by arithmetic sum of liquidity of all members of JV. The offer of bidder who do not enclose the certificate(s) in support of liquidity duly fulfilling liquidity conditions will be summarily rejected.

Financial Bid: The financial bid consists of schedule of rates: The tenderer has to quote rate in figures in financial bid in "GeM portal "only. Rates quoted anywhere else will not be considered.

Evaluation of Financial bid: In case, the evaluated financial offers of two or more technically qualified bidders are lowest and same, then the contract will be awarded by " **Run L-1 selection** " feature of GEM which works on pseudorandom number generator algorithm.

2.0 Evaluation of Technical Bid:

2.1 Bidder's Credentials:

2.1.1 If on the basis of information contained in the first packet, the Tender Committee needs clarification regarding processes, specifications etc., communication can be initiated with the bidders. In seeking clarifications, all communications with bidders shall be properly recorded so that an audit trail is maintained. Clarifications shall be confined to the documents/information already submitted by the bidder.

2.1.2 The bidders shall submit a certificate in the prescribed format as per **Annexure-N** for verification/ confirmation of the documents submitted for compliance of eligibility / qualifying criteria. Non submission of the certificate, or submission of certificate either not properly filled in, or in a format other than the prescribed format shall lead to summary rejection of your offer.

After opening the financial bid, the tender committee shall verify the credentials of the bidder who is declared as the lowest bidder (L1) for their authenticity. In case the credentials of L1 are not found to be in order, their bid shall be treated as technically unresponsive and thus invalid. The process shall be repeated for the next higher bidder till the valid L1 is established. If any document (or copy thereof) submitted by a bidder is found to be false / forged:

(a) The bidder /each partner /member of the bidding firm shall be liable to legal actions apart from punitive actions, as decided by competent authority of Railways. In such an eventuality, the bid (bid) shall also be summarily rejected.

(b) If the contract has already been awarded, or Letter of Acceptance (LOA) has been issued and any, the contract shall be terminated, irrespective of the stage of progress in execution of the work. In such an eventuality, Security Deposit (SD), Performance Guarantee (PG) and partial / full payments otherwise due to the contractor, in respect of the partial / full work executed by the contractor, shall be forfeited by the Railways.

(c) Other punitive actions, like banning the bidder and partners /members of the bidding firm for future dealings with Indian Railways and / or the Government of India may also be taken by the Railway / Govt. of India authorities.

2.1.3 The bidder shall submit along with the Bid document, documents in support of their claim to fulfil the minimum eligibility criteria as mentioned in the bid.

2.1.4 The bidder shall be required to produce self-attested copies of the relevant documents in support of their credentials for being considered during technical evaluation. The bidder shall submit along with the Bid document, documents in support of their claim to fulfil the minimum eligibility criteria as mentioned in the bid.

2.2 Disqualification of bidders:(as per para 2.5.1 and 2.5.2 of GCC for services, 2018)

(a) Should a bidder be a retired Manager of the Gazetted rank or any other Gazetted officer working before her retirement, whether in the executive or administrative capacity or whether holding a pensionable post or not, in any department of any of the railways owned and administered by the President of India or the time being, or should a bidder being a partnership firm have as one of its partners a retired Manager or retired Gazetted Officer as aforesaid, or should a bidder being an incorporated company have any such retired Manager or retired officer as one of its Directors or should a bidder have in her employment any retired Manager or retired Gazetted Officer as aforesaid, the full information as to the date of retirement of such Manager or Gazetted Officer from the said service and in case where such Manager or Officer had not retired from Government service at least 2 years prior to the date of submission of the tender as to whether permission for taking such contract, or if the contractor be a partnership firm or an incorporated company, to become a partner or Director as the case may be, or to take the employment under the contractor, has been obtained by the bidder or the Manager or Officer, as the case may be from the President of India or a

ny officer, duly authorised by her in this behalf, shall be clearly stated in writing at the time of submitting the bid. Bids without the information above referred to or a statement to the effect that no such retired Manager or retired Gazetted Officer is so associated with the bidder, as the case may be.

The format in **Annexure -R** shall be submitted at the time of participating in the bid. Non-submission shall lead to **SUMMARILY REJECTION** of offer.

(b) Should a bidder or contractor being an individual on the list of approved Contractors, have a relative(s) or in the case of partnership firm or company of contractors one or more of her shareholder (s) or a relative (s) of the shareholder(s) employed in gazetted capacity in any department of the Railway, the authority inviting tenders shall be informed of the fact at the time of submission of tender, failing which the tender may be disqualified/rejected or if such fact subsequently comes to light, the contract may be rescinded in accordance with provision in Clause 7.4 of GCC(Services) 2018.

The format in **Annexure-S** shall be submitted at the time of participating in the bid. Non-submission shall lead to **SUMMARILY REJECTION** of offer.

Other Terms and Conditions:

i. Partnership Deeds, Power of Attorney Etc.: The bidder shall clearly specify whether the bid is submitted on her own or on behalf of a partnership concern. If the bid is submitted on behalf of a partnership concern, she should submit the certified copy of partnership deed along with the tender and authorization to sign the tender documents on behalf of partnership firm. If these documents are not enclosed along with tender documents, the tender will be treated as having been submitted by individual signing the tender documents. The Railway will not be bound by any power of attorney granted by the bidder or by changes in the composition of the firm made subsequent to the execution of the contract. It may; however, recognize such power of attorney and changes after obtaining proper legal advice, the cost of which will be chargeable to the contractor.

ii. The bidder whether sole proprietor, a limited company or a partnership firm if they want to act through agent or individual partner(s) should submit along with the tender or at a later stage, a power of attorney duly stamped and authenticated by a Notary Public or by Magistrate in Favor of the specific person whether she/they be partner(s) of the firm or any other person specifically authorizing her/them to submit the tender, sign the agreement, receive money, witness measurements, sign measurement books, compromise, settle, relinquish any claim(s) preferred by the firm and sign "No Claim Certificate" and refer all or any disputes to arbitration.

iii. The bidder shall clearly specify whether the bid is submitted on her own or on behalf of a Partnership Firm/Joint Venture (JV)/Society etc. The bidder(s) who is/are constituents of Firm, Company, Association or Society shall enclose self-attested copies of the Constitution of their concern, Partnership Deed and Power of Attorney along with their bid. Bid Documents in such cases shall to be signed by such persons as may be legally competent, Association or Society, as the case may be.

iv. The bidder shall give full details of the constitution of the Firm/JV/Company/Society etc. and shall also submit following documents (as applicable), in addition to documents mentioned above:

a. Sole Proprietorship Firm: The bidder shall submit the notarized copy of the affidavit.

b. Partnership Firm: The bidder shall submit self-attested copies of (i) registered/notarized Partnership Deed and (ii) Power of Attorney duly authorizing one or more of the partners of the firm or any other persons(s), authorized by all the partners to act on behalf of the firm and to submit & sign the Bid, sign the agreement, witness measurements, sign Measurement Books, receive payment, make correspondences, compromise/settle/relinquish any claim (s) preferred by the firm, sign 'No Claim certificate', refer all or any dispute to arbitration and to take similar action in respect of all Bid s/contracts OR said Bid/contract.

c. Joint Venture (JV): The Bidder shall submit documents as mentioned in Clause 2.4 to GCC.

d. Company registered under Companies Act-1956: The Bidder shall submit (i) the copies of MOA (Memorandum of Association) and AOA (Articles of Association) of the Company; and (ii) Power of Attorney duly registered/notarized by the company (backed by the resolution of Board of Directors) in favour of the individual, signing the Bid on behalf of the Company.

e. Society: The Bidder shall submit (i) self-attested copy of the Certificate of Registration, (ii) Deed of Formation and (iii) Power of Attorney in favour of the Tender signatory. If it is mentioned in the Bid that it is being submitted on behalf of/by a Sole Proprietorship Firm/Partnership Firm/Joint Venture/Registered Company etc.

c., the aforementioned document/s (as applicable) should be enclosed along with Bid.

If it is NOT mentioned in the Bid that it is being submitted on behalf of/by a Sole Proprietorship Firm/Partnership Firm/Joint Venture/Registered Company etc., then the Bid shall be treated as having been submitted by the individual who has signed the Bid. After opening of the Bid, any document pertaining to the Constitution of the Firm/JV/Society etc. shall neither be asked nor be entertained/considered. A Bid from JV/Consortium/Partnership Firm etc. shall be considered only where permissible as per the Bid/Tender conditions.

X) Following conditions to be included as special conditions in the hiring Tender document/Agreement:

1. The vehicle provided under contract should have FASTag, which should be provided invariably for faster movements of vehicle at toll area 24 x 7, to reach the work spot in time without causing any delay.
2. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regard. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.
3. Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.
4. While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.
5. The tenders/service providers have to pay 5% of Security deposit/EPBG to the railways. If any guidelines issued by Railway Board, SCoR headquarters or any railway organization for change in percentage of Security deposit/EPBG, the same will be applicable.

6. Bidders found to have a conflict of interest shall be disqualified. A bidder may be deemed to have a conflict of interest with one or more parties in this bidding process if:

- a) They have a common controlling partner(s),

- c) They share the same legal representative/agent for the purpose of this bid,
- d) The bidder participates in more than one bid in this bidding process for the same item/consignee. Participation of bidder through multiple bids for item wise-consignee wise evaluation will result in the disqualification of all bids involving the concerned parties. However, this does not restrict the inclusion of components/sub-assemblies/assemblies from one bidding manufacturer in multiple bids.
- e) In cases of agents quoting in offshore procurement on behalf of their principal manufacturers, one agent cannot represent two manufacturers or quote on their behalf in a particular tender inquiry. One manufacturer can authorize only one agent/dealer. Only one bid may be submitted by either:
 1. The manufacturer (OEM) directly or through one Indian agent on its behalf.
 2. An Indian/foreign agent on behalf of only one OEM.
- f) The bidder or any of its affiliates participated as a consultant in the preparation of the design or technical specifications of the contract that is the subject of the bid.

g) Multiple bids are received by different bidders from the same IP address for the same item wise-consignee wise evaluation.

7. Disputes if any, the decision of the Sr. DMM/GNT is final.
