1. **Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. **Buyer Added Bid Specific ATC**

ATC

1. The bidding party is required to upload proof of turnover and experience.
2. Delivery of all items specified in the bid must be ensured.
3. Items must be supplied strictly in accordance with the uploaded specifications and quantities. If the supplied items do not match the specified requirements, the party must take them back at their own expense.
4. It is mandatory to supply at least 95% of the total bid quantity; otherwise, the work order will be cancelled. Payment will not be made for the items that are not supplied.
5. The legal jurisdiction shall be Surat.
6. ITI Sachin reserves the right to cancel the published bid at any stage.
