SCOPE OF WORK

1. The work involves technical expert guidance and support for calibration of all flame scan-ners and gravi metric feeders in Unit-1 of NTPL during major overhaul. The firm shall de-pute experienced Ex-BHEL engin eer for carrying out the same.

2. CI 001 - Testing and Calibration of Flame Scanner (28 nos) & Gravimetric feeders (8 nos)

a. Calibration of Flame Scanners (28 nos):

b. All the flame scanners (28 no's) to be individually healthiness checked, calibrated as per standard proce dure.

c. Firm's engineer shall make adjustments in head electronics and flame processor mod-ule if necessary. A ll the field cables shall be check for noise pick-up and the same is to be rectified.

d. Firm's engineer will make and provide checking/calibration report of each flame scan-ner and if required , will recommend the spares to be replaced/repared for accurate working of the scanner.

e. Firm's engineer shall study the performance of the flame scanner during light up and make necessary tu ning at various loads, if required.

f. Calibration of Gravimetric Feeders (8 nos):

g. Each feeder will be individually inspected.
