14. Once warranty period on battery completes, DGVCL will free to replace the UPS battery with same or higher quality any other make battery from any vendor. However this will not affect warranty on UPS.

15. Inspection will be carried out at Plant/ Factory for 10% samples Unit with Input voltage range test, output voltage range test, Visible and audible alarm test, Backup test and other required testes as per DGVCL requirement. In case of Testing facility is not available at Plant/ Factory all these testes will be performed at NABL accredited Lab only. The charges/Expenses of Inspection, Testes and Inspectors will be borne by Bidder. OEM has to give undertaking to that effect in MAF. For 10% samples, Inspection and Testes will be performed at Warehouse having backup test and other testes with adequate environment and facilities.
