2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE 50% : The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 50 percent with the consent of the service provider

2. Buyer Added Bid Specific Scope Of Work(SOW)

Text Clause(s)

- (1) **Rates and Price Breakup:** The bidder must quote rates in 'Annexure-A' as per the attached Price Breakup sheet. Quoted rates must include all charges for printing, materials, and delivery to this office, as well as all applicable taxes and incidental expenses. Bidders should carefully consider these terms while quoting. This office shall not be held responsible for any misinterpretation or misunderstanding in this regard.
- (2) **Registered Office Location:** The registered office address of the bidder must be located within Kutch District. The bidder must compulsorily submit GST registration Certificate as a documentary evidence for geographical location.
- (3) **Non-Blacklisting Undertaking:** The bidder must upload an affidavit confirming that the firm/party has not been blacklisted by any other government department, office, or organization.
- (4) **Financial Turnover Criteria:** The bidder must have an average annual financial turnover of at least ₹20 Lakhs over the last three financial years CA Certificate to be uploaded as documentary evidence for turn over criteria.
- (5) **Work Experience:** The bidder must submit workorders demonstrating a minimum of 3(Three) years of experience in executing similar nature of work.
- (6) **Contract Period and Performance:** Upon satisfactory performance of the successful bidder, the contract duration may be extended for an additional period of 1 (one) year after completion of the initial contract term. If the service is found unsatisfactory during the contract period, the contract may be terminated at any time without prior notice.
- (7) **Data Confidentiality and Security:** The bidder shall strictly ensure the confidentiality and security of all data related to the printing work under this contract. The relevant material/data shall not be sold, shared, or used for any other purpose other than supplying it to this office.

- (8) **Political Non-Affiliation:** The bidder participating in this tender must not be associated with or be a member/office bearer of any political party/organization. An affidavit to this effect must be submitted by the bidder.
- (9) **Acceptance of Terms:** Before starting the work, the successful bidder must submit a declaration on the letter head of the firm.
- (10) **Option Clause (Quantity Variation):** The buyer reserves the right to increase or decrease the contract quantity by up to 50 percent at the time of issue of the contract or during the currency of the contract.
- (11) **Earnest Money Deposit (EMD):** Bidders can submit the EMD via an Account Payee Demand Draft (DD) drawn in favor of [Deputy District Election Officer, Kachchh], payable at [Office of the District Election Officer & Collector Kachchh, Bhuj]. The bidder must ensure that the original Demand Draft (DD) in hard copy reaches this office on or before the last date of bid submission.
- (12) **Price Schedule Excel Sheet:** The Excel sheet for financial bidding will be made available in the bid document. Bidders must fill out the required details and upload the file along with the documents.
- (13) **Form of EPBG:** The successful bidder can submit the Performance Security in the form of a Fixed Deposit Receipt (FDR) in addition to Performance Bank Guarantee (PBG). The FDR should be pledged in the name of [Deputy District Election Officer, Kachchh] or marked as A/C (Name of the Seller). The issuing bank must certify that the deposit can only be withdrawn upon demand or with the explicit sanction of the pledgee. For the release of the deposit, the Buyer will endorse, sign, and stamp the back of the FDR along with a covering letter. The bidder must upload a scanned copy of the FDR in place of the PBG and deliver the original FDR hardcopy to the Buyer within 15 days of the award of the contract.
- (14) **Price Bid Calculation & L-1 Evaluation:** In the attached Price Breakup Excel sheet (Annexure-A), the bidder must quote the unit price (per page) for the estimated quantity mentioned in Column (D) and calculate the total amount accordingly. Bidding will be evaluated based on the total aggregate amount calculated. The bidder with the lowest overall total price among all qualified parties will be declared as L-1. *(Example: For an estimated total of 60,000 pages at a rate of ₹1.00 per page, the total quoted amount shall be $60,000 \times ₹1.00 = ₹60,000/-$).*

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.

5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and
- All operative provisions of the erstwhile Labour Laws until their complete substitution.

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.

This Bid is governed by the [सामान्य नियम और शर्तें/General Terms and Conditions](#), conditions stipulated in Bid and

[Service Level Agreement](#) specific to this Service as provided in the Marketplace.
