If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. 4. 6. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the

manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

8. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

9. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

1. Generic

OPTION CLAUSE 50% : The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 50 percent with the consent of the service provider

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

The AMC shall be awarded initially for a period of two years, extendable by another year on satisfactory performance and mutual consent, on the terms and conditions specified in this tender document.

Estimated Cost of Tender: ₹1,50,000/- (One Lakh Fifty Thousand only)

Scope of Work:

1. Diagnose the fault and rectify the defects detected in reasonable time.
2. Repair /replace the faulty parts etc. of the equipment's.
3. Carry on the Platinum preventive maintenance (at least once in a month) as per schedule.
4. Attend all break down calls as and when required.
5. Upkeep the system, recording, required reading and Platinum maintenance of log Book of works carried out.
6. Monthly Platinum preventive maintenance checklist (brake, safety gear, ropes, ARD, door sensors, etc.).

1. NIAM may seek clarifications on documents, failure to respond may lead to rejection.
2. Experience/ documents must be in the bidder's name only. Incomplete/ invalid bids will be rejected.
3. Only technically qualified bidders will be eligible for financial evaluation. L-1 (lowest offer) will be considered successful.
4. Contract valid for 2 years, extendable by another year on satisfactory performance.
5. Downtime: day of call closure not counted, repeated failures due to poor repair will be treated as contin

uous downtime.

6. Vendor must maintain fault/repair records signed by NIAM authority.

7. The successful bidder shall furnish a Performance Security Deposit equivalent to 5% of the total contract value in favour of Director General, CCS NIAM, Jaipur within 15 days of award of contract. The Performance Security shall remain valid for 90 days beyond the completion of contract period. It will be released after successful completion of AMC and submission of all reports, subject to deduction of penalties, if any.

8. In case of any fault in equipment, the firm has to attend the fault and be set right within 48 hours within reporting, failing which will invite a penalty of ₹500/- per day subject to maximum of 10% of contract value.

9. Repetitive faults or recurrence of the same fault due to poor quality of repair/maintenance may be treated as unsatisfactory performance and may lead to termination of the contract, after giving due notice.

10. Bidders are advised to inspect the Lift system before quoting. It shall be deemed that the bidder has full knowledge of the installation and its condition, whether or not such inspection has been carried out.

11. NIAM reserves the right to accept/reject any bid without assigning reasons.

12. NIAM reserves the right to terminate the contract by giving two month's written notice in case of unsatisfactory services, safety violations, or breach of terms.

13. Any dispute arising out of this contract shall be referred to the Director General, CCS NIAM, Jaipur, whose decision shall be final. Jurisdiction of courts shall be Jaipur only.

Payment Terms:-

1. Payment will be released on a quarterly basis.

2. The contractor shall submit bills within two weeks of completion of each quarter, along with downtime/maintenance reports duly certified by the Engineer-in-Charge.

3. CCS NIAM will reconcile the downtime/penalty, if any, and release payment within

4 weeks of submission of complete bills. 4. No advance payment shall be made under any circumstances.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
