If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
4. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover shall upload the supporting documents to prove his eligibility for Relaxation.
5. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which

no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 6. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. 7. Inspection of Stores by Nominated Inspection Authority / Agency of buyer or their authorized representatives

An independent third party Professional Inspection Body can help buyer in mitigating buyer's risk with pre-dispatch/post-dispatch inspection in order to ensure that equipment, components, solutions and documentation conform to contractual requirements. The buyer has a right to inspect goods in reasonable manner and within reasonable time at any reasonable place as indicated in contract. Inspection Fee/ Charges (as pre-greed between buyer and Inspection Agency) would be borne by the buyer as per their internal arrangement but may be recovered from the seller if the consignment failed to conform to contractual specification and got rejected by the Inspection Officer .If so requested and accepted by the seller , initially seller may pay for inspection charges as applicable and get the same reimbursed from buyer if consignment accepted by the Inspecting Officer . For reimbursement seller has to submit proof of payment to Inspection Agency.

Seller/OEM shall send a notice in writing / e-mail to the Inspecting officer / inspection agency specifying the place of inspection as per contract and the Inspecting officer shall on receipt of such notice notify to the seller the date and time when the stores would be inspected. The seller shall, at his own expenses, afford to the Inspecting officer, all reasonable facilities as may be necessary for satisfying himself that the stores are being and or have been manufactured in accordance with the technical particulars governing the supply. The decision of the purchaser representative /inspection authority regarding acceptance / rejection of consignment shall be final and binding on the seller.

The Seller shall provide, without any extra charge, all materials, tools, labour and assistance of every kind which the Inspecting officer may demand of him for any test, and examination, other than special or independent test, which he shall require to be made on the seller's premises and the seller shall bear and pay all costs attendant thereon.

The seller shall also provide and deliver store / sample from consignment under inspection free of charge at any such place other than his premises as the Inspecting officer may specify for acceptance tests for which seller/OEM does not have the facilities or for special/ independent tests.

In the event of rejection of stores or any part thereof by the Inspecting officer basis testing outside owing to lack of test facility at sellers premises, the seller shall, on demand, pay to the buyer the costs incurred in the inspection and/or test. Cost of test shall be assessed at the rate charged by the Laboratory to private persons for similar work.

Inspector shall have the right to put all the stores or materials forming part of the same or any part thereof to such tests as he may like fit and proper as per QAP/governing specification. The seller shall not be entitled to object on any ground whatsoever to the method of testing adopted by the Inspecting officer.

Unless otherwise provided for in the contract, the quantity of the stores or materials expended in test will be borne by seller.

Inspecting officer is the Final Authority to Certify Performance / accept the consignment. The Inspecting officer's decision as regards the rejection shall be final and binding on the seller.

The seller shall if so required at his own expense shall mark or permit the Inspecting officer to mark all the approved stores with a recognised Government or purchaser's mark.

2. The following **Pre- qualification criteria** will be followed by participating firms -

(i) Only OEM or OEM authorized dealer of make mentioned in nomenclature of item can participate in the tender.

(ii) Participating firms shall produce the documentary evidence (Authorization certificate) in support of OEM /OEM authorized dealer along with technical bid. The credentials of bidder may be verified, if required.

3. **Tender specification**- Firm will quote & supply as per Tender specification and annexure No.MCO/07141.Any deviation from TE specification, offer may be ignored. No conditional offer will be accepted. Firm will comply all the points of Annexure OFC/20260557 and submit the documentary evidence in support of these points. In case of Non- compliance /non-submission of any documents, offer may be ignored.

4. **Earnest Money Deposit (EMD)**- Rs 50,910.00 along with technical bid in form of Fixed Deposit Receipt or Bank Guarantee from any of the commercial banks in favor of Ordnance Factory Kanpur. The bidder seeking EMD exemption, must submit the valid supporting document for the relevant category as per GeM ATC with the bid. Under MSE category, only manufacturers for goods and Service Providers for Services are eligible for exemption from EMD. Traders are excluded from the purview of this Policy.

5. **Performance security deposit (PSD)**- 05% of the contract value if contract value is more than 10 Lakhs. PSD may furnish in form of Fixed Deposit Receipt/ Bank Guarantee from a Commercial Bank. Performance Security is to be furnished by a specified date (generally 30 days after notification of the award) and it should remain valid for a period of 60 days beyond the date of completion of all contractual obligations of the supplier, including warranty obligations, if any.

6. **RFI (Request for information)**-

- i. Participating firms will submit required conclusive documents along with technical bids. Purchaser may not ask any deficient document for clarification through RFI. In case of non-compliance/non submission of any documents offer may be ignored.
- ii. During evaluation and comparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be given asking the tenderer to respond by a specified date. If the tenderer does not comply or respond by the date

ate, his tender will be liable to be rejected. Depending on the outcome, such tenders are to be ignored or considered further. The shortfall information/ documents should be sought only in case of historical documents which pre-existed at the time of the tender opening and which have not undergone change since then. So far as the submission of documents is concerned with regard to qualification criteria, after submission of the tender, only related shortfall documents should be asked for and considered. For example, if the bidder has submitted a supply order without its acceptance/ performance certificate, the certificate can be asked for and considered. However, no new supply order shall be asked for so as to qualify the bidder.

- iii. Please note that participating firms cannot change its originally submitted technical offer during technical bid in RFI, if clarification asked. Firm will submit the clarification only with respect to originally offered product. Change in originally offered technical specifications shall not be permitted and considered for technical evaluation.

7. Option clause – Not Applicable

- 8. Liquidated damages- The standard Liquidated Damages percentage is 0.5% per week (or part thereof) of the prices of any stores/ service which the contractor has failed to deliver within the original delivery period specified in the contract. The ceiling of LD is 10%.
- 9. Ground rent- If the material supplied by the vendors is rejected at the factory premises, the vendor is required to lift the rejected material within 30 days of issue of rejection letter. Factories have right to recover a charge for the storage space at @1% of the cost of material un-cleared, per week or part thereof, with maximum ceiling of 10% of value of the items. After lapse of 10 weeks, if it is found that firm has not taken any action for lifting of items, the goods may be confiscated and disposed off as per disposal procedure in vogue after sending a notice and giving 30 working days time to the firm. Ground rent shall be calculated from the date of expiry of the period of removal of item. No ground rent should be charged from Central/State Govt/Central PSUs. When the firm fails to pay the applicable ground rent within the prescribed period, factory is entitled to recover the ground rent due and all incidental expenses from EMD/PSD.
- 10. Inspection- After receipt of material, CGM/ Ordnance Factory Kanpur or his auth. rep (Board of Officer).
- 11. Firms Offer should be based on FOR basis. The delivery destination is Ordnance Factory, Kanpur (OFC), otherwise offer is liable to be rejected. Unloading of goods at OFC will be done by supplier. The stores should be properly packed for tropical storage and for transport by rail, road, sea or air so as to ensure and to protect them against loss, damage, corrosion in transit on arrival at their destination. The packing and marking of packages shall be done by and at the expense of the seller.
- 12. Guarantee/warranty clause- Warranty period of the supplied products shall be one year from the date of final acceptance of goods at consignee location. OEM warranty certificate must be submitted by successful bidders at the time of delivery. Any defective stores shall be repaired /replaced to the satisfaction of the consignee or replaced at his premises free of cost immediately on notice. The buyer reserves the right to inspect the stores on receipt and discrepancy or defects found shall be reported to the Seller within a period specified in the contract and the seller shall rectify the same within a period specified in the contract on receiving the intimation.
- 13. Cancellation of supply order – CGM/OFC reserves the right to cancel the supply order after expiry of original delivery period without any intimation. All dispute arising out of any contract/ order placed as a result of this tender shall be referred to the sole arbitrator of the CMD/ Advance Weapons & Equipment India Ltd Kanpur or any officer appointed by him.
- 14. Payments terms- The standard payment terms shall be 100% payment against Seller's bill by Account transfer through NEFT/RTGS only for accepted materials within 30 days from the date of receipt of material or submission of bills/documents, whichever is later.
- 15. Acceptance of Goods - Material on arrival at Buyer's premises will be inspected by Inspection Department (QC/QA) as per appropriate Quality Assurance Plan/user trail basis/visual inspection/test certificate provided by suppliers and their decision in this matter will be final. The test ce

rtificate and relevant supporting documents should be sent along with the consignment by supplier.

Award of contract - Contract shall be awarded to the successful bidder whose bid has been determined to be substantially responsive, the lowest evaluated bid, technically & financially acceptable, and successful in type approval/validation tests (where applicable) done by the purchaser. The purchaser reserves the right to negotiation against price quoted by any bidder.
17. GST Details- Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST%. Bidders will indicate GST Registration Number. Bidders must provide a copy of GST Registration Certificate and indicate the HSN code of the item, if applicable. Bidders must submit Invoice with due registration number of GST along with delivery challan at the time of delivery. Material will not be allowed inside the factory without invoice. If bidder fails to make the payment of the GST as charged in the invoice or file the return for the corresponding period of supplies made to factory. In such cases of any default, factory shall not make payment of GST component and reserve the right to withhold entire payment and will recover the interest and fine levied by the GST authorities, if any, due to default made by the bidder. To claim the GST component from factory supplier must clear its mismatch if any in invoice filed in the GSTR-1 and submit a copy of GSTR-3 filing Acknowledgement with the factory.
18. The purchaser will have right to delete the established firm who quote in CARTEL from the list of approved source, debar them from competing for a period decided by the purchaser which is firm and final.
19. Firms should quote for full tender quantity. Offers for quantity less than tendered quantity will be considered unresponsive and liable to be rejected, if CARTEL formation is suspected. The OFC, reserves the right to order any quantity on one or more firms. Wherever all or most of the approved firms quote equal rates in CARTEL, the purchaser will have right to place order on any one or more firms with exclusion of rest. The selection of firms for placement of order would be based on a pre-determined ranking of the firms. The price quoted by participating firms this tender should be firm and fixed.

20. Arbitration Clause-

(i) All disputes or differences arising out of or in connection with the present contract including the one connected with the validity of the present contract or any part thereof, should be settled by bilateral discussions.

(ii) Any disputes or differences arising out of or in any way touching or concerning this agreement (except those for which specific provision has been made therein) shall be referred to Sole arbitrator to be appointed by the CMD, AWEIL, Ordnance Factory Kanpur, Kalpi Road, Kanpur- 208 009 with the mutual consent of the parties. The Arbitrator so appointed shall be a Government Servant / Ex Government Servant (with mutual consent) who had not dealt with matter to which this agreement relates and in course of his duties had not expressed views on all or any of the matter in dispute or differences. The Award of Sole Arbitrator shall be final and binding on the parties. Further, the arbitration proceedings would be subject to the provisions of Arbitration and Reconciliation Act 1996 (Amended in 2015) and the rule thereon and the guideline issued by the Government of India in this regard.

(iii) The venue of the arbitration shall be at place of concerned Factory.

21. Except with written consent of the buyer, the participating bidders shall not disclose any technical specifications, plan, drawings, patterns, or information thereof, to any third party, unless the same is already available in public domain.

22. Ordnance Factory, Kanpur is an ISO: 14001 certified company and all its vendors are advised not to indulge in any practice which pollutes the environment at the time of delivery of stores.
