- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

10. **Generic**

1. The quoted product will be evaluated as per the required specification of the department as attached in ATC. GeM Parameter selection is only for selection of product to create the bid under the GeM portal as reference. Hence, bidder is requested to quote the items as per the specification of the department as specified in the ATC.

2. All the bidders need to produce the samples for evaluation without fail and same will be intimated to the quoted firms in order to conduct evaluation as per specification requirement of the department (attached in ATC) and necessary testing mentioned in it.

3. If required, in order to check the battery type etc, the sample will be disassembled for testing / evaluation purpose of protection circuit etc.

4. Data sheets / test sheet of the actual quoted make and model of the product along with necessary certificate should be uploaded during the bid submission in order to avoid delay / rejection etc as specified in this bid.

5. Warranty should be as per the departmental requirement as mentioned in specification (find in attached pdf under ATC with specification details) for all quoted items. Needs to submit necessary undertaking letter for the same and this should be submitted along with bid submission without fail.

6. The participating bidder needs to submit all the documentary proof / testing certificates etc. as detailed under Technical Specification of department attached under ATC.

All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
