If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE 25% : The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 25 percent with the consent of the service provider

2. Buyer Added Bid Specific ATC

1.0 Eligibility Criteria

The bidder who wishes to participate in the tender shall fulfil the following eligibility criteria.

1.1. Technical Eligibility Criteria

1.1.1. The Bidder should have successfully completed either of the following similar work/s (defined below) for a period of at least 1 year during the last seven years ending on the last day of

the preceding month in which tender is floated:

- a. One similar work of executed / completed value not less than Rs. 41,43,150/- including GST

OR

- b. Two similar works of executed / completed value not less than Rs. 33,14,520/- including GST

OR

- c. Three similar works of the executed / completed value not less than Rs. 24,85,890/- including GST

A. Definition of Similar work: Upkeep and Maintenance or House Keeping/Cleaning/ Sanitation work under Facility Management.

B. Documents to be submitted for establishing eligibility:

Bidder shall submit self-certified copies of work order(s) and completion / performance certificate(s) issued by client / other supporting document as documentary evidence to substantiate their meeting the technical eligibility criteria specified at cl. no. 4.1.1 above.

- i. In case, the bidder has submitted the GeM work order/completion certificate for Manpower outsourcing services (GeM catalogue) indicating various resource deployment, the same can be accepted only if the order matches the resource deployment categories related to Upkeep and Maintenance or House Keeping/Cleaning/Sanitation Services only as per the definition of similar works. However, the completed value for the respective portion for applicable resource deployment as per similar work definition only will be considered during evaluation.

1.2. Financial Eligibility Criteria

1.2.1. The average annual financial turnover of the Bidder during last (3) three consecutive financial years ending 31st March' 2025 shall not be less than **Rs. 33,14,520.00**

1.2.2. In order to substantiate the above turnover requirement, bidder shall submit signed copy of **Audited Annual Financial Reports** (Balance Sheet and Profit & Loss Account statement) clearly indicating the details of the Membership No. & Firm No. of the Chartered Accountant & UDIN as per guideline of ICAI.

1.2.3. In case of non-availability of Audited annual reports for any genuine reasons, as an alternate, with reasoned proof, the bidder may submit certified annual turnover from a practicing-chartered accountant, duly notorised, in support of their financial credentials, in lieu of annual reports. The Chartered Accountant's Certificate should clearly indicate the details of the Membership No. & Firm No. of the Chartered Accountant and the UDIN.

1.2.4. In case of Companies / Firms which are less than three (3) years old, the average annual turnover of the bidder shall be calculated by considering the turnover as per the audited annual report or Chartered Accountant's certificate submitted by the bidder for available period divided by three (3).

1.2.5. In case of Companies / Firms which are more than three (3) years old, bidders are mandatorily required to submit audited reports or CA certificate for all the three (3) consecutive financial years failing which their offer will be liable for rejection.

1.2.6. Annual financial turnover of entities participating in the tender on their own strength only shall be considered and not their related entities like holding Company, subsidiaries or group Companies etc. i.e., Bidder shall be independent legal entities and shall have its own independent financial accounting system as per laws of the land.

Note:

- 1. Relaxation of 15% in prequalification criteria with respect to Prior Turnover to MSE and 20% in case of SC / ST and women MSE enterprise shall be applicable**
- 2. Relaxation of 20% in prequalification criteria with respect to Prior Turnover to Start-ups shall be applicable.**

1.3. Joint Venture (JV) / Consortium bidding is not allowed for this tender.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.

7. Seeking sample with bid or approval of samples during bid evaluation process. 8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws,
