7. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. SCOPE OF WORK

1. Conduct and Behaviour:

The driver shall maintain a polite, courteous, and disciplined demeanour at all times while on duty. He shall follow the instructions of the SDE/ JE/ Officers in Charge diligently.

2. Uniform and Personal Appearance:

The driver shall wear a neat and clean uniform during duty hours.

3. Cleanliness and Upkeep of Vehicle:

The driver shall ensure that the vehicle is clean, well-maintained, and in good running condition at all times. Daily cleaning (both interior and exterior) shall be mandatory before commencement of duty.

4. Toll / FASTag Management:

The driver or agency shall ensure that the vehicle's FASTag is active and sufficiently funded at all times to

avoid delays at toll plazas. Any delay due to non-availability of FASTag balance will be the responsibility of the agency.

5. Driving Competence and Technology Use:

The driver must possess basic knowledge of smartphone applications, including Google Maps navigation, and must be able to follow location coordinates / digital maps when required during field visits.

6. Safety and Compliance:

The driver shall strictly adhere to traffic rules and safety norms as prescribed under the Motor Vehicles Act 1988 & its amendment(s). Any penalty arising from violation of such rules shall be borne by the agency.

7. Availability and Timeliness:

The vehicle and driver shall be available on all working days and also on call at other days when required to this office. The driver must report punctually at the designated time and place of duty.

8. Confidentiality and Conduct at Work Sites:

The driver shall maintain confidentiality regarding official movements, field visits, and any data or document accessed in the course of duty.

9. Substitution of Driver:

In case of leave or absence of the regular driver, the agency shall ensure immediate replacement with a qualified and experienced driver having a valid license, without affecting service continuity.

10. Liability and Insurance:

The vehicle must be comprehensively insured, and all liabilities arising out of accident, theft, or damage shall rest with the agency. The agency shall indemnify the Department against any claims arising thereof.

8. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

i)The Contractor shall not be allowed to transfer, assign, pledge or sub-contract its services under any circumstances without written permission of the officer-in-charge. **The vehicle deployed by the agency shall strictly be in ownership of the proprietor or the firm, failing which the bidder shall be disqualified and appropriate action against the firm shall be taken. Agency will have to upload Vehicle documents (i.e. RC, Insurance, PUC, etc).**

ii)Vehicle shall be finalized by the Engineer in charge among the options given in bid and as per utility/ requirement of the office.

iii)Rates quoted by the bidders would remain firm, valid and fixed up to contract duration. No request for escalation on any ground including the increase in the price of petrol, Minimum Wages/Salary for Driver, vehicle price, insurance, maintenance, road tax, etc. shall be entertained. The bidder should quote reasonable rate (not a merge amount) for the outstation night charges to cover the food and lodging expenses of the drivers while on tour. The selected bidder shall have the responsibility for arrangement of food and accommodation of the driver. The hiring authority will not bear any cost for providing accommodation and food during the period for which the vehicle is hired).

iv)The vehicles must have clean seat covers/upholstery, good look and should be in perfect running condition fulfilling the latest emission norms prescribed by Transport Authority. It may be noted that the monthly/ daily/ weekly lump sum amount to be paid to the bidder includes all costs involved such as cost of petrol/Driver salary/ maintenance charges/ incidental charges, etc. round the clock services, the Saturdays, Sundays and holidays i.e. taking into consideration of the working day on requirement basis as & when required. viii)The Contractor has to ensure that vehicles deployed are comprehensively insured and claims, if any shall all be directly entertained by the Contractor from the Insurance Company. Division/Office shall not be responsible for any damage to the vehicle in case of an accident or otherwise, theft of vehicle/parts and accessories therein. Similarly, include award given by Motor Accident Claims Tribunal (MACT) or any other Court or Competent Authority, and the Agency/ selected bidder will be liable to pay any such award or compensation for damages caused to life and property by the vehicle.

ix)The Service provider shall provide the vehicle with commercial number plate.

x) If the vehicle is out of order or if condition of vehicle is found to be unsatisfactory, Contractor shall provide a substitute vehicle immediately. In case, vehicle does not report on time or does not report at all, the Office would have a right to hire a vehicle from the market and cost incurred by the Office will be deducted from the bills or any other payment payable to the contractor.

xi) The vehicle must be equipped with clean and comfortable seat covers, upholstery, and seat cushions to ensure comfort for officers. If the vehicle is not found suitable by the office, the bidder must change the vehicle within three days.

12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.

This Bid is governed by the [सामान्य नियम और शर्तें/General Terms and Conditions](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace.
