1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
3. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered by the Bidder or its reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization, in at least one of the last three Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and invoices to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of product having highest value should meet this criterion.
4. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro Enterprises dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product or service. Traders are excluded from the purview of Public Procurement Policy for Micro Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will be satisfied based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatic. If the MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band, the Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) per cent discount. Bidder is advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be as per the GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidder and shall have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of bid by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
6. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar product or service in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization, in support of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.
7. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
 - i. If number of technically qualified bidders are only 2 or 3.
 - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
 - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
 - iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1.
 - v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25% of the quantity placed under the contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the quantity ordered under the contract at the contracted rates. The delivery period of quantity shall commence from the last date of order. If the option clause is exercised during the extended delivery period the additional time shall commence from the last date of order. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, if the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser shall not be liable for any delay in delivery up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

3. OEM

IMPORTED PRODUCTS: In case of imported products, OEM or Authorized Seller of OEM should have a registered service support in India. The certificate to this effect should be submitted.

4. Sample Clause

After award of contract – Successful Bidder shall have to get advance sample approved from buyer before bulk supply. Successful Bidder shall submit

samples for Buyer's approval, within 7 days of award of contract. Buyer shall, as per contract specifications for sample or will provide complete list of modification required in the sample within 7 days of receipt of advance supply as per approved sample with modifications as communicated by Buyer. If there is delay from buyer side delivery period shall be refixed without LD for the period of delay in sample approval. In case, the sample is found conforming to the Contract specifications, the buyer at its discretion may call for fresh samples for approval but terminate the contract after notifying the deviations to the seller.

Unless otherwise provided in the contract, all samples required for test shall be supplied by the contractor free of cost. If the contractor is required to submit an advance sample, any expenses incurred by the contractor on or in connection with the sample before the sample has been approved unconditionally shall be borne by the Seller and he shall not claim any compensation being found unacceptable by the Buyer / Consignee.

5. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Manpower for unloading the material at the consignee's premises shall be arranged by the supplier at its own cost.
2. Any material rejected due to poor quality, manufacturing defects, expiry, damage, or non-conformity with the specification shall be replaced by the supplier at its own cost within the stipulated time. Transportation and incidental expenses shall be borne by the supplier.
3. Delivery Schedule:
Monday to Friday: 09:30 AM to 04:00 PM
Saturday: 09:30 AM to 01:00 PM
4. Sundays and Government Holidays: No delivery.
5. Supply orders shall be placed on a staggered delivery basis, ordinarily once every three months, depending on the requirement of the Buyer's department.
6. The supplier may make part supply against the supply order and upload invoices only for the quantity supplied.
7. Each supply order issued under the contract shall be completed within 15 days from the date of issue of order by the consignee. Delay beyond the stipulated period shall attract action as per the applicable provisions of Contract. Liquidated Damages (LD), wherever applicable.
8. Details of supplies executed during the preceding three years to Government Hospitals/Medical College shall be furnished, if called for during evaluation.
9. The supplier shall ensure that the quoted items conform to the technical specifications approved by the Buyer, including certificates, test reports, wherever applicable.
10. The shelf life of the supplied consumables/reagents shall not be less than 80% of the total shelf life or minimum shelf life on the date of delivery (modify as per your requirement).
11. Materials shall be supplied in original manufacturer's sealed packing with batch number, manufacturing date, and expiry date clearly visible.
12. No substitution of brand, model or specification shall be permitted without the prior written approval of the Buyer.
13. The supplier shall replace any defective or non-performing material reported during the warranty/validity period. No further action may be taken as per the GeM Contract.
14. Performance Security shall be furnished within the time prescribed under the GeM Contract. In case of failure to furnish within the stipulated period, action shall be taken in accordance with the terms and conditions of the GeM Contract and other consequential actions, wherever applicable.
15. The bidder shall furnish documentary evidence of having supplied similar reagents compatible with the medical Colleges/Institutions during the preceding three years, wherever applicable.
16. The bidder shall furnish details of similar supplies successfully executed during the preceding three years to Government Hospitals, Autonomous Bodies, PSU's or other reputed institutions, indicating the name of the purchaser, description of the order/work order number, and date of supply. Copies of the relevant supply orders and completion certificates, if available, may also be furnished.
17. Sample of tissue embedding ring shall be submitted at the time of technical evaluation for assessment of requirements.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent , for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to issue any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Sourcing.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension is applicable.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specific MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders, the Contract will be awarded by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional tender items. If buyer needs more items along with the main item, the same must be added through bunching category based bid or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, the seller must raise the same by using the Representation window provided in the bid details field in Seller dashboard after logging in. GeM will reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020 and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force in India.
