The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. **10. ##### 1. Generic

**OPTION CLAUSE:** The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

6. The OEM should have 3 years of experience in manufacturing such equipment and more than 50 engineers/technicians in their manufacturing facility. The certificate of incorporation should be submitted along with the list of employees with proof of ESI and EPF deducted.
7. OEM/Bidder must have supplied of at least four numbers of Geo synthetic Pull-out Equipment & one number of Cyclic Large Direct Shear System in last three years to NIT/IIT/CSIR Labs/Government Organizations/ NABL Labs/PSU from the date of floating of tender. Bidder should submit copy of purchase order/supply order/tax invoice and performance certificate of buyers as documentary evidence in support of the previous supply.

8. Original catalogue of the equipment is required otherwise quotation may not be considered and treated as cancelled (Original catalogue should not be printed on letter head)
9. Bidder/OEM should have product is displayed on the website, original catalogue of the equipment and product displayed on the website should be same otherwise quotation may not be considered and treated as cancelled.
10. During the technical evaluation phase, the buyer reserves the right to request an online product demonstration from any bidder in order to verify compliance with the required specifications and assess product quality. The bidder must arrange and present the online demonstration within five (5) days of receiving such a request. Failure to comply may result in rejection of the bid.
11. Bidder should submit valid ISO 9001, ISO 45001 and ISO 14001 certificate of OEM.
12. Payment will be released only after satisfactory delivery, installation, demonstration and acceptance of goods at our Institute.
13. Escalation Matrix for after-sales support to be provided.
14. All products should carry a 1-year warranty.
15. The prices must be inclusive of GST, packing, freight, unloading, installation etc.
16.
