If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. During the technical evaluation phase, the buyer/ concerned department reserves the right to request a product demonstration (online/offline) from any bidder to verify compliance with the required specifications and assess product quality. The bidder should arrange and present the demonstration within five (5) days of receiving such a request. Failure to comply will result in the technical rejection of the bid.
6. All equipment should carry 01 Year comprehensive onsite warranty from the date of successful installation. The bidder must submit an undertaking on their letterhead regarding the provision of warranty; otherwise, the bid will not be considered.
7. The quoted prices should be strictly F.O.R. Destination and inclusive of GST, packing, forwarding, freight, unloading, installation, and commissioning at the designated site/location of NIT Patna.
8. If required, the successful bidder has to arrange to provide user training of the equipment at the consignee location without any additional cost.
9. Payment will be released only after satisfactory delivery, installation, commissioning, demonstration and acceptance of the equipment by the user department and completion of all contractual formalities as per GeM provisions.

12. The Buyer reserves the right to verify any information or document submitted by the bidder from the issuing authority, OEM or any other appropriate source and may seek any additional document or clarification during the evaluation process. Failure of the bidder to furnish the required clarification or documents within the stipulated time may result in rejection/disqualification.

13. Earnest Money Deposit (EMD): Bidder has to submit bid security declaration in lieu of EMD as per Annexure – I attached under ATC.
