Special terms and conditions-Version:1 effective from 05-12-2025 for category Wheeled Fire Extinguishers (V3) ISI Marked to Is 16018

1. This category is BIS Scheme - 1 compliant. Catalogs must have valid and active CM/L license number owned by the applicant themselves. In case of non-compliance, appropriate action may be taken against OEM / Brand / Seller as per the GeM IM Policy.

The gas shall be supplied compressed in Cylinder. The design of the Cylinder, pressure of gas in Cylinder, packing, marking, painting, labelling, storage and transport of Cylinder shall be in accordance with the Gas Cylinder Rules , with such modifications as may be ordered from time to time by the CIE, PESO, DPIIT, MoC&I, Gol.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Provisions for workmen compensation, insurance, public liability, property damage, insurance etc. to be ensured by the contractor. Also, safety measures prescribed for working in Extra High Voltage & use of personnel protective equipment must be adhered to.
3. **Scope of Supply**

Scope of supply (Bid price to include all cost components) : Only supply of Goods

Bid Specific Terms and Conditions

1. **Completion of supply within 30 Days.**
2. **Payment after satisfactory Completion of Supply at site.**
3. **Guarantee of the work shall be for a period of 12 months from the date of Completion.**
4. **Before submitting final bill, firm is required to produce purchase vouchers in original.**
5. **Scanned copy of original affidavit which should be issued & made after the date of publication of tenders & within the due date, duly verified by notary giving undertaking that the firm has not been blacklisted/debarred by any Govt./ Semi-Govt Department & has not left any work abandoned during Last 3 years (latest).**
6. **The firm shall submit the scanned copy of GST registration, Latest ITR, GST Return (Latest), and PAN Card.**
7. **The bidder should be authorized by OEM for this bid and should upload the same authorization issued by OEM only. Bid specific OEM authorization has to be submitted.**
8. **The firm shall submit the scanned copy of completion certificate, not older than last Three years for satisfactory completion of similar nature or work/supply.**
 - a) **Single completion certificate of at least 60% of estimated bid value; or**
 - b) **Two completion certificate of at least 40% each of estimated bid value ; or**
 - c) **Three completion certificate of at least 30% each of estimated bid value.**

9. The firm should submit undertaking that it's no near relative is working in DJB, if relative working in DJB then relation must be given.
10. The bid has to be quoted by bidder with valid NABL Lab test reports & BIS License certificate & endorsement certificate (IS:16018).
11. The firm should submit undertaking that the documents are certified and true & in case found false/fake, the Department shall be at liberty to take action against the erring bidder along with the rejection of bid and shall not only be liable to blacklisting of firm from DJB but appropriate legal action shall be taken.
12. Bidders shall have to submit the scanned copy FDR against EMD with the bid documents and submit Original/Hard copy to this office within 01 working day of the opening of technical bids so that same can be considered for opening of financial bid.
13. Documents submitted by the contractor should be legible/readable/visible, etc. failing which tender will be liable to be rejected. It is mandatory to attach all documents as required with technical Bid of NIT.
14. Mandate from shall be signed by bank and firm representative.
15. Allied rules & regulations prevailing in DJB will also be applicable.
16. Firm has provided telephone no for attending onsite complaints during guarantee period.
17. EMD as per NIT shall be deposited amounting to Rs.27600/- in favour of EE (E&M) M-8. On <http://services.sabpaisa.in/pages/demo/djboard.html>, <http://delhijalboard.nic.in/home/delghi-jal-board-djb> /FDR is also acceptable, Original FDR should reach the office within 24 Hr of opening of technical bid.
18. In case the quoted rates are more than 25% below the departmental justification, then the bidder is required to deposit an additional performance guarantee for the difference amount of 25% below rates and the quoted rates before issue of work order.
19. The bidder should be OEM or Authorized by OEM for this bid and should upload BID specific authorization from OEM (Signed & stamped copy) along with bid documents.
20. The bidder/OEM should have executed project for supply for same category product in past through GEM with completion certificate (CRAC Certificate) and same should be uploaded at the time of bidding.
21. The bid has to be quoted by bidder for 45Ltr water mist with Valid BIS License Certificate with BIS Product Listed Endorsement Certificate for IS 16018.
22. The bidder/OEM must submit valid NABL-accredited laboratory test reports for all quoted products as per mentioned in Bid and same should be uploaded at the time of bidding.
23. The bidder must quote and participate for all items/products mentioned in the Bid. Any bidder who fails to quote for all products shall be marked as disqualified and the bid will be rejected.
24. Test Certificates and Warranty/ Guarantee Certificates to be submitted at the time of delivery.
25. OEM should be registered in State Pollution Control board, ISO- 9001, ISO 45001 and CE product listed marked Certificate within the last one year from the bid submission date and the same should be uploaded while submitting the bid otherwise bidder will be rejected.
26. A minimum fire rating of 233B for B class fire for 45ltr water mist (IS 16018) is mandatory for participation.
27. Valid GST Registration Certificate.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
