1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
4. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

1. Generic

OPTION CLAUSE 50% : The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 50 percent with the consent of the service provider

2. Provisions for workmen compensation, insurance, public liability, property damage, insurance etc. to be ensured by the contractor. Also, safety measures prescribed for working in Extra High Voltage & use of personnel protective equipment must be adhered to.

3. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

The following documents need to be uploaded on GeM Portal for as part of eligibility criteria for qualify in Technical Bid.

- a. Copy of the DGR sponsorship Letter.

ADDITIONAL TERMS AND CONDITIONS

1. DGR Agency shall provide uniformed and trained ESM / personnel and use its best endeavor to provide the desired security Services to the Department.
2. Rates quoted shall include all statutory obligations of the DGR Agency.
3. All kinds of taxes shall be borne by DGR Agency except GST.
4. If the minimum wages are revised by the DGR, the incremental wages, if applicable, will be provided by the Department. Agencies are advised to provide rate accordingly.
5. The commercial quotes which are not in compliance of Minimum Wages Act, DGR norms or any other Labour laws will be rejected outrightly.
6. The term of this contract shall be for a period of 2 years from the date of signing of the contract and can be extended further for 6 months period in one go but maximum period of 2 years on mutual consent basis subject to satisfactory performance. However, the decision for grant of extension shall be solely at discretion of the department.
7. No advance payment will be sanctioned to the Agency.

8. Compensation claimed by the Manpower will be sole liability of the Agency.
9. The courts in Delhi shall have the exclusive Jurisdiction to try all disputes, if any arising out of this agreement between the parties.
10. Agency/Contractor shall be liable for recovery of liquidate damage for default on their part as per provision of GFR 225(xvi).
11. No claim for the payment from contractor shall be entertained after the laps of three year of arising of the claim.
12. Award of Contract under DGR sponsorship: In the eventuality of all the DGR sponsored Agencies quoting the same rates, the Buyer Department shall award the contract to the senior-most sponsored Agency. The order of seniority of sponsored agencies / corporation shall be as indicated on the DGR sponsorship letter.
13. **Death of Inmates/Residents:** In the event of the death of any inmate/resident of the Observation Homes attributable to the negligence of the Security Agency, the Competent Authority of the Department shall have the right to terminate the contract of the Security Agency with immediate effect. In addition, the Fidelity Bond furnished by the Security Agency may also be forfeited.
14. **Compliance with Bid Conditions:** The Security Agency shall strictly comply with the GeM General Terms & Conditions, Service Level Agreement (SLA), Scope of Work, and all Additional Terms & Conditions stipulated in the bid document throughout the contract period.

The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
