If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.

2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. 3. 4. 5. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

6. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. **Generic**

OPTION CLAUSE 25% : The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 25 percent with the consent of the service provider

2. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. The below mentioned Buyer Added text-based ATC clauses will have privilege over SLA.
2. The services Provider must own at least one commercial/Taxi vehicle in Service Provider's name or in the name of the proprietor/partner of the Service Provider. Necessary documents relating to proof of ownership MUST be uploaded by the bidder for verification of the buyer.
3. Only BS6-compliant Commercial/Taxi vehicles shall be deployed by the Service Provider, if awarded the contract under this bid.
4. The vehicle should be white in color, in good working condition, well maintained, and free from any major scratches/dents/ any history of serious accidents. The interior and exterior of the vehicle shall be cleaned daily before reporting to duty.
5. The vehicles deployed must be equipped with the following additional accessories/utilities:
 - a. Tool Box & Stepney.
 - b. First aid box and torch.
 - c. Clean Seat Covers/White Towels and Floor Mats etc.
 - d. Hand Sanitizer
 - e. Tissue paper box
 - f. Car Air Freshener
 - g. Mobile charging facility
 - h. Seat Belts (Front and Rear seats)
 - i. Fire Extinguisher
 - j. white colour curtains
 - f. name display
6. The Vehicle shall be made available on Saturday/Sunday/Non-working days, if required.
7. In case of breakdown or servicing of the primary vehicle, the agency must provide a stand-by vehicle of similar type and condition within an hour. Failure to do so shall attract penalty @Rs500/day at every instance.
8. GPS-enabled vehicle tracking and mobile phone availability with driver is desirable to ensure tracking and safety.
9. All vehicles and drivers must comply with the latest provisions of the Motor Vehicles Act, pollution norms, and applicable central/state government regulations.
10. A monthly review of services will be conducted, and unsatisfactory performance may lead to appropriate penalties or termination of the contract.
11. A well-trained, courteous, and experienced driver shall be deployed. Frequent changes of driver should be avoided. Drivers deployed with vehicles must meet the following criteria, which override any SLA provisions: -
 - a. Hold a valid driving license.

- b. Wear a neat and clean uniform during duty, if prescribed. Uniform costs shall be borne by the Service Provider.
 - c. Well-acquainted with the roads and localities within the Bhopal Municipal Area. Preference should be given to local drivers.
 - d. Must have a mobile phone; costs shall be borne by the Service Provider.
 - e. Exhibit professional behavior, follow proper etiquette, and maintain a courteous demeanor at all times.
 - f. Drivers found under the influence of alcohol or drugs shall be removed immediately from duty, and such incidents may lead to termination of the contract.
12. The following penalties shall be imposed in case of defaults/defect in service:
- a. Late Reporting: Rs 100/- per day
 - b. Non reporting of vehicle/Driver: Rs 500/- per instance + the actual amount incurred by the department if taxi/vehicle hired by the department from market/third party, would be deducted from bill of the Service Provider. Repeated instances may lead to termination of the contract.
 - c. Refusal of duties: Rs 500/- per instance + the actual amount incurred by the department if taxi/vehicle hired by the department from market/third party, would be deducted from bill of the Service Provider. Repeated instances may lead to termination of the contract.
 - d. Non-Adherence to Dress Code: Rs 100/- per day.
13. Duty hours: The duty hour shall be normally for ten (10) hours from 09:00 AM to 7:00 PM. However, the duty hours can be changed based on the requirement of the office. The payment for Over time allowance (OTA)/Extra Hours shall be as per SLA. The OTA shall be allowed only when duty hours exceed to 10 hours and exceeding monthly limit of 260 hours. Duty shall include 6 consecutive days and one leave thereafter.
14. Outstation duty: The vehicle will be used for outstation as and when required.
15. All expenses relating to fuel, maintenance, servicing, insurance, challans, and driver's salary shall be borne by the contractor.
16. Adjustment of Unused Kilometers: Unused KMs, if any, during a particular month (as per Monthly KM slabs) will be carried over to the subsequent 03 MONTHS and will be adjusted against any extra KMs if performed over and above the agreed slab for the vehicle.
17. (i) The Purchaser reserves the right to increase/decrease the quantity by 25% at the time of placement of contract or during the currency of the contract at the contracted rates. The bidders shall be bound to accept such orders as and when placed.
- (ii) Duration of the Service Contract may be extended up to 06 Months beyond the initial contract duration. The Service Provider shall be bound to continue providing services on the same terms and conditions for the first 3 months of extension. The subsequent 3-month extension shall be subject to mutual consent of both parties, on the same terms and conditions.
18. Buyer reserves the right to terminate the contract anytime with a 30 days' notice to the Service Provider, without assigning any reason.
19. Any matters not explicitly covered under this agreement shall be resolved by the Addl.DGT, MP LSA, Bhopal. The decision of this office shall be final and binding.
20. While the office has a regular need for vehicle services, it reserves the right to suspend or discontinue the service at any time, without prior notice or justification.
21. An office of the Service Provider MUST BE located in the state of consignee i.e., Madhya Pradesh (MP). Documentary Evidence to be submitted.
22. EMD/ PBG must be from Nationalized bank.

23. Only MSE Bidders for Services are eligible for exemption from EMD. Relevant supporting documents in this regard is to be submitted.

24. Toll charges or Parking charges will be paid extra on the production of the payment receipt.

3. **Generic**

6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export

experience.

9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
