1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original

delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. **Generic**

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

1. Inspection clause:

- a) Inspection & Testing of the material shall be carried out by NSPCL at Store / Site after receipt of the material. Acceptance of the material shall depend upon such inspection.
- b) All sampling & testing of the material shall be carried out as per IS: 266:1993 (Reaffirmed) taking/incorporating its latest revision & amendments.
- c) Acceptance of material shall be based on purity testing done at site and compliance of rest of the parameters in MTC (from manufacturer/NABL Accredited laboratory/Govt approved Lab) with our specification.
- d) Purity test at NSPCL site may be witnessed by the agency after taking prior permission from HOD (Chemistry).
- e) Purity of the material shall be Acidity of the material referred as "Total acidity (as H₂SO₄), percent by mass" in all the cases of this procurement.

2. Guarantee/ warranty Clause:

The supplier shall stand Guarantee / Warranty for the material supplied, until and unless accepted by NSPCL after inspection at Central Stores.

8.0 Payment Terms: Lotwise, 100% advance payment. Reconciliation of the payment shall be done at NSPCL after final delivery upon receipt of the actual material at respective NSPCL site.

8.1 Required acidity of the material shall be 98.0%. However, material of acidity below 98% shall be accepted up to the acidity of 97.0%, subject to pro-rata price deduction. In such case, payment shall be made as per following formula.

Unit rate of payment per MT = (PO Rate X Actual acidity of supplied material) / 98.0

Where, 98.0% shall be taken as PO Purity of the material.

Material of the purity below 97.0% shall not be accepted at all.

Bidders are advised to quote "rate per MT on 98.0% acidity basis" only.

8.2 Price Variation Clause:

a) All Pricing elements shall be as ruling on date of dispatch.

b) At the start of each month, IOCL shall provide their declared monthly Ex-works price. This shall be treated as base rate of that month.

So above PVC may be incorporated in the proposal.

9.0 Delivery period and Schedule:

9.1 This indent deals only with material cost. Transportation of the material is in the scope of NSPCL. i.e. from M/s IOCL to NSPCL Rourkela site a separate service PO will be placed. NSPCL shall arrange road tanker through external agency.

9.2 Lot size will be 30 MT (approx). Actual delivery date of each lot shall be as per site requirement which shall be communicated to the supplier by the user Dept. 15 days in advance.

9.3 LD shall be applicable only, if the material is not supplied within 15 days (max.) from the date of communication from site.

9.4 LD shall be 0.5 % for one week delay and maximum of 5.0 % of Net value of dispatched Lot.

9.5 Material unloading at Site: The material shall be unloaded at site, directly into storage tanks of DM Plant/CW System.

9.6 Mode Of Supplies: By suitable road tanker (as per clause 5.1 & 5.2 of IS 266: 1993) in the scope of NSPCL. NSPCL shall arrange road tanker through external agency.

11.1 QUANTITY VARIATION:

Indented quantity can vary from +/- 5.0 % of quantity awarded in PO.

11.2 NSPCL authorised transporter will deploy tankers for loading at IOCL Haldia refinery. Respective IOCL office shall provide all assistance and shall coordinate with authorized transporter for entry/ exit of tankers and lifting of material.

11.3 Loading of Tankers to be on First in First Out basis. IOCL shall allow the tankers reported at their gate on the same day for loading and dispatch (subject to fulfilment of all conditions by transporter as per IOCL rules).

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. 11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main

item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.
