1. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.
3. 4. 7. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
9. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or

For release of Security Deposit, the FDR will be released in favour of bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Successful Bidder has to upload scanned copy of the FDR document in place of PBG and has to ensure delivery of hard copy of Original FDR to the Buyer within 15 days of award of contract.

23. **Financial Criteria**

NET WORTH: Net Worth of the OEM should be positive as per the last audited financial statement.

24. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. Bidder shall be the Original Equipment Manufacturer (OEM) or an OEM Authorized Dealer/Distributor/Channel Partner.
2. Valid OEM Authorization Certificate shall be submitted by non-OEM bidders.
3. OEM Compatibility Certificate confirming 100% compatibility with the make, model and OEM Part Number mentioned in the BOQ is mandatory.
4. OEM Product Catalogue/Data Sheet mentioning OEM Part Number and specifications shall be submitted.
5. Only Original, New, Unused and Genuine OEM Consumables are acceptable. Compatible/Equivalent/Substitute/Third-party/Reprocessed/Refurbished consumables are not acceptable.
6. Wherever applicable, valid CDSCO Manufacturing/Import Licence, ISO 13485 and statutory approvals shall be submitted.
7. Consumables shall not adversely affect equipment performance, calibration, safety or warranty.
8. Self-declaration claiming OEM status without documentary evidence shall not be accepted.
9. Purchaser reserves the right to verify all documents directly from the OEM. False documents may result in rejection as per applicable GeM/GFR provisions.
10. Bidder shall quote only consumables matching the OEM Make, Model and Part Number in the BOQ.
11. Original sealed OEM packing with batch/lot details and expiry (where applicable) is mandatory.
12. Residual shelf life shall be minimum 75% or 12 months, whichever is applicable.

13. Defective, damaged or incompatible consumables shall be replaced free of cost.

14. Purchaser's decision regarding technical suitability and document verification shall be final.

2 Other Conditions as below:

a. Attach GST registration and PAN No in Bid document.

b.. Non Conviction certificate on Rs.100/- stamp paper duly notarized non blacklisting or non debarred in India in any government / Semi Govt./Autonomous. Organization etc. and affidavit regarding lowest quoted rates.

c. Key User list along with performance certificate for quoted items.

d. Registration certificate of the manufacturer.

e. Full address, fax no, phone no & E-mail of principal firms. All documents uploaded with tender form should be neat and clean and readable

f. Service Center in U.P with details, address, location, Contact no. and no of service Engineers deployed.

g. Other documents required for eligibility and qualification of bidder Turnover CA certified Audited Balance sheet.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1

14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document.
