2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior

written consent of buyer.

3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

2. The supply must strictly confirm to the standards specified. However, at the sole discretion of UPSACS, if GSM of supplied material is less than 1% to 5% less of specified GSM, deduction of 5% and more than 5% to 10% less of specified GSM, deduction of 15% of shall be applicable on item wise total cost. GSM deficiency of more than 10% will not be acceptable. 3. The printer shall convert it into suitable version/format and print after necessary approval from UPSACS. New art work or Conversion cost, if any shall be borne by the bidder.
5. Selected firm shall submit two sets of printed material after its development for checking of contents and proof-reading purposes. On its verification (duly signed & stamped) firm shall retain one set of verified & cleared (ok) specimen and second set will be retained by UPSACS.
6. Two soft copies of finally verified Printed materials shall be made to UPSACS in following format:

8. If any time it was proved that bidder have given false information or uploaded any fake document in bid proposal. The Society will not consider such bid proposal for evaluation and EMD/EPBG will be Forfeited and the process of blacklisting will be initiated against the firm.
