1. The minimum average annual financial turnover of the bidder during the last three financial years, ending on 31st March of the previous financial year, should be as indicated in the bid document. The turnover of the bidder shall be validated by the system based on the financial data available on the GeM portal. The average turnover shall be calculated based on the last three financial years where data is available; in case data is available for only two of the last three financial years, the average shall be computed based on those two years. In case the date of constitution / incorporation of the bidder is less than three years old, the average turnover in respect of the completed financial years after the date of constitution / incorporation shall be taken into account for this criterion. No separate documentary evidence is required to be uploaded by the bidder for this criterion, as the system shall derive and validate the turnover figures from the data available on the GeM portal.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March

prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

1. **Generic**

OPTION CLAUSE 25% : The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 25 percent with the consent of the service provider

2. **Past Project Experience**

Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. Any other document in support of contract execution like Third Party Inspection release note, etc.**Proof for Past Experience and Project Experience clause:** For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. 3. **Forms of EMD and PBG**

Successful Bidder can submit the Performance Security in the form of Fixed Deposit Receipt also (besides PBG which is allowed as per GeM GTC). FDR should be made out or pledged in the name of

For release of Security Deposit, the FDR will be released in favour of bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Successful Bidder has to upload scanned copy of the FDR document in place of PBG and has to ensure delivery of hard copy of Original FDR to the Buyer within 15 days of award of contract.

1. Technical Eligibility Criteria

The bidder must meet all of the following technical eligibility conditions:

i. **Years of existence**

- a. The bidder organisation shall have been in continuous existence for more than 3 years from the date of incorporation/registration and shall be engaged in consultancy / advisory services in infrastructure / waste management services / urban services/ or related domains during this period. Proof regarding the same will have to be submitted.

ii. **ISO certification**

- a. The bidder shall hold valid ISO certification (ISO 9001 for Quality Management Systems, ISO 14001 for Environmental Management Systems and ISO 45001 for Occupational Health & Safety or equivalent).
- b. Self-certified copies of valid ISO certificates shall be submitted with the bid.

iii. **Experience with Government / Urban Local Bodies**

- a. The bidder shall have prior experience of providing consultancy services in similar works (DPR preparation, feasibility reports, RFP/tender drafting, bid process management) for Government/Semi-Government/Public Sector/Urban Local Bodies within India during the last 3 years. Experience Certificate regarding satisfactory work report or Completion of work should be enclosed certified by the concerned department and only work order enclosed will not be sufficient. moreover ongoing projects (for current financial year 2026-27) will not be considered for above criteria, only completed projects will be taken into account.
- b. The bidder must have successfully completed:
 - i. One similar assignment with project cost not less than 80% of the estimated cost of the present assignment, OR
 - ii. Two similar assignments each with project cost not less than 50% of the estimated cost of the present assignment, OR
 - iii. Three similar assignments each with project cost not less than 40% of the estimated cost of the present assignment.
- c. "Similar assignment" shall mean consultancy for DPR/RFP/bid process management in MSW or closely related urban environmental infrastructure sectors (e.g. water/wastewater, river rejuvenation, sanitation) as defined in the bid document.
- d. In addition to the above, bidders who have submitted detailed methodology for waste management works - covering work methods, scheduling and material sourcing in sufficient detail - shall also be considered eligible, provided that:
 - such methodology has been clearly mentioned and documented in the RFP / work order / agreement of the respective waste management assignment; and
 - the bidder submits copies of the relevant RFP / work order / agreement (or extracts thereof) along with the bid, evidencing the methodology, work methods, scheduling and material sourcing details referred to above.

iv. **Key Personnel Capability**

- a. The bidder shall have, or be able to deploy, a qualified team comprising at least the following key experts: Team Leader, Waste Management Expert, PPP/ EPC Financial Expert/Certified CA.

Team Leader (Waste Management & Environmental Services)

The Team Leader shall have extensive experience in the waste management field, with not less than 3 years of rich professional experience in the waste management and environmental services sector. experience letter regarding the same should be submitted.

Over the course of career, the Team Leader shall have held senior leadership roles

such as Project Head, General Manager – Projects, Chief Operating Officer, and/or Director with well-established and reputed organisations in the industry, demonstrating proven capability in leading large, complex waste management / environmental projects.

The Team Leader shall be responsible for overall leadership of the assignment, quality assurance of all deliverables (DPRs, RFP/tender documents, bid process outputs), stakeholder coordination with the Municipal Corporation and other agencies, and supervision of all other key experts deployed under this consultancy.

The CV of the proposed PPP / EPC Financial Expert, clearly demonstrating the above experience and qualifications, shall be submitted with the bid along with a signed consent letter confirming availability for the assignment.

v. Regulatory registrations

- a. The bidder shall possess valid PAN, GSTIN, and any other statutory registrations applicable to consultancy services, and shall not be blacklisted/debarred by any Central/State Government, PSU, or multilateral funding agency. The bidder should submit Power of Attorney for Authorized Signatory & original physical hard copy of Power of Attorney for Authorized Signatory should be submitted by the Bidder before bid submission date & time. A Bidder, in the last Three (3) Years, have neither failed to perform any Contract, as evidenced by imposition of a penalty by an Arbitral or Judicial Authority or a Judicial pronouncement or arbitration award against the Bidder, as the case may be, nor has been expelled from any project or contract by any public entity nor have had any contract terminated by any public entity for breach by such Bidder. An affidavit on Rs. 100 stamp paper regarding same should be submitted by the bidder. The bidder should have registered office in India & should submit proof of same.

VII. Average annual turnover

The bidder's average annual turnover for the last 3 financial years ending 31-Mar-2026 shall be more than INR **33.00 Lacs** from consultancy/services business.

Audited balance sheets and Profit & Loss accounts and a certificate from a Chartered Accountant indicating turnover for the last 3 years shall be uploaded with the bid. In case the Annual accounts for the last Financial Year are not audited and therefore the Bidder cannot make it available, the Bidder shall give an undertaking to this effect, certified by the Statutory Auditor/Chartered Accountant. In such a case, the Bidder shall provide the Audited Annual Reports for last 5 Financial Years preceding the latest Financial Year for which the Audited Annual Report is not being provided.

VIII. Net worth

The bidder should have positive Net worth during last 3 Financial Year CA Certified certificate (with UDIN No) Should be attached.

1. Performance Security, EMD

i. Earnest Money Deposit (EMD)

- a. The bidder has to submit EMD of an amount of **INR 33,000.00 (Thirty Three Thousand)**.

- b. Bidders are allowed to submit EMD through digital modes (RTGS/NEFT/internet banking) or Demand Draft. Scanned proof of payment / instrument shall be uploaded along with the bid.
d. Physical copy of EMD should be submitted by the last date of Tender/Bid submission date, Relaxation's to MSME/Startup will be given as per Govt. of Uttarakhand Go No. 1542 Dated 20-08-2019.

ii. **Performance Bank Guarantee (PBG / EPBG) / Performance Security**

- a. Performance Security shall be applicable for this consultancy contract. The Performance Security amount (equivalent to 05% of the Contract Value. The validity period (covering the contract period and defect liability period) is 1.2 years.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of

this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:
