11) Supply shall be made in Single lot.

12) LIABILITY UNDER WORKMEN COMPENSATION ACT:

The contractor shall at all time indemnify the Purchaser against any claim which may be made under the Workmen Compensation Act, 1923 or any statutory modifications thereof or otherwise for or in respect of any damage or compensation payable in consequence of any accident, death or injury sustained by any worker or person in the employment of the contractor.

13) Self-Certification under preference to MAKE IN INDIA Order Certificate: As per 'Make In India' policy, all bidders must furnish MII document as per format enclosed herewith. (WITH PROPER DATE, GEM BID NUMBER, ITEM DETAILS, BIDDER REF., COMPLETE MII VALUE ADDITION ADDRESS IN DETAIL ETC.).
