1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
3. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The

buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

7. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 10% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

8. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

- 1) The Bidder/OEM/System Integrator of the of the lead items - Classroom / Interactive flat panel display / Innovation Laboratory / Digital Learning Infrastructure projects for Government Departments, PSUs, Educational Institutions, Universities or Autonomous Bodies during the last five years. Copies of Purchase Orders and Completion Certificates shall be submitted.
- 2) The Original Equipment Manufacturer (OEM) of Interactive flat panel item must be classified as a Local Supplier under the Make in India policy, with a clear declaration of the Country of Origin. A Certificate of Incorporation must be appended to the bid documentation.
- 3) The OEM of the AI-Enabled interactive flat panel display shall have a minimum annual turnover of 100 Cr. from the sale of Interactive Flat Panels (55" or above) in each of the last three financial years (FY 2022-23, FY 2023-24, and FY 2024-25). The OEM must have been profit-making for each of the last 05 financial years. Bidders must submit CA-certified financial statements, along with all supporting schedules, as evidence of both turnover and profitability. The bid must also include Income Tax Returns (ITRs) for the last three consecutive financial years and GSTR- 3B filings for the most recent three months.
- 4) The OEM of the quoted Interactive Flat Panel Display (IFPD) must have a presence in India for a minimum period of ten (10) years as of the bid submission date. The bidder shall submit a statutory document as per company registration act.
- 5) Earnest Money Deposit (EMD): An EMD amounting to **INR 1,00,000 (one Lac Only)** must be pledged in favour of the Chief Education Officer, Ganderbal, and submitted along with the bid proposal. Failure to comply will lead to disqualification of the bidder.
- 6) The bidder seeking EMD exemption must submit the valid supporting document for the relevant category as per GeM terms and condition with the bid. Under MSE category only manufacturers of goods and service providers for services are eligible for exemption from EMD.
- 7) Quoted Interactive flat panel display OEM should be in the Interactive Flat panel (Size 55" or above) business from last 10 years with its own brand (10-year-old Government purchase order of Interactive Flat panel with OEM's Brand to be submitted as proof).
- 8) The OEM must possess a valid active BIS certification for the quoted model of Interactive Display issued at least five (5) years prior to the bid submission date. This will demonstrate the OEM's continued manufacturing experience and compliance with BIS standards.
- 9) The OEM of the quoted Interactive Flat Panel must have a manufacturing/Contract Manufacturing or assembling unit operational in India for a minimum of five (5) years. The address of the local manufacturing unit shall be clearly mentioned on the BIS certificate.

- 14) The OEM should also be registered with ESIC, copy of latest paid challan should be attached with the bid.
- 15) The Technical Compliance of the Interactive flat panel display, , Podium, Furniture (Dual Desk), solar inverter setup and AI-Enabled Teaching and Tracking Application offered in the bid must be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.
- 16) Broucher And Catalogue: The bidder shall upload along with the BID, the original Manufacturers product broucher/catalogue of the quoted products/items clearly indicating make and technical specification. The product supplied by the successful bidder shall strictly conform to the make and specifications, configuration and technical parameters offered and accepted during the tender process. Any deviation or substitution from the approved/quoted product shall not be permitted and may result in rejection of the product, non-acceptance of the supply and/or action as per the terms and conditions of the contract.
- 17) The Bidder will submit an undertaking and affidavit on non-judicial stamp paper of one hundred Rupees that the firm has not been debarred/ blacklisted for any other Central/ State Government. Dept./ University/ PSU etc.

- 19) Upload Manufacturer authorization: Wherever Authorized Distributors/dealers are submitting the bid, bid specific Manufacturers Authorization Form (MAF)/Certificate with OEM details for the Interactive flat panel display, Furniture (Dual Desk) solar inverter setup, podium and AI-Enabled Teaching and Tracking Application such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid.
- 20) The OEM of the Interactive flat panel display must not have been suspended on any Government procurement portal at any time during the preceding 24 months. The bidder shall submit valid proof of non-suspension or furnish complete details of any suspension history.
- 21) OEM of the Interactive Flat Panel Display must be registered with the Central/State Pollution Control Board in compliance with E-waste/EPR guidelines (CPCB certificates from 2021 onwards to be submitted).
- 22) The bidder shall supply only new, unused and latest available models. Refurbished or end-of-life products shall not be accepted.

- 31) Submission of false information, forged documents or misleading declarations shall lead to rejection of the bid and may invite further action as per applicable rules.
