1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any

Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

6. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

General Terms and Conditions

1. Only the Original Equipment manufacturer (OEM) shall be eligible to participate in the bidding process.
2. Comprehensive Maintenance service Contract is valid for one year from the award of GeM bid.
3. You shall provide 04 preventive Maintenance service during contract, at regular intervals.
4. You will be attending to all breakdown calls as and when wanted/ required. There will be no limit of break down calls.
5. The company will appoint a Nodal Officer. The company/ Nodal Officer will be informed of the complaints through mobile/ E-Mail. The mobile number and E-Mail address of the company and nodal officer will be provided at the time of contract by the company.
6. The Comprehensive Maintenance Contract will include all services/ repairs/ spare parts.
7. Exclusion, if any, should be submitted along with the price with CMC proposed.
8. Each and every complaint will have to be attended within 24 hours, however in case of default ESIC may increase the CAMC period by equivalent hours, This excludes Saturday, Sunday and any government holidays.
9. Repairing should be completed within Seven Days from the receipt of the c

omplaint.

10. The company will have to guarantee a maximum 95% number of days of working of the equipment in a year. If guaranteed uptime is not maintained, then warranty shall be extended by double the downtime period exceeding 5%.
11. In case any equipment/ machines remains non-functional/ non-working for more than seven days, A penalty of 0.5% of the total bill amount per week up to a maximum of 10% of the bill amount will be deducted from subsequent bills. Overall liability under this contract is 10% of total CAMC Value. Or In case of downtime exceeding 7 days, the warranty will be exceeded by double the downtime period beyond agreed downtime of 5%.
12. The continuation of order/approval letter/ Comprehensive Maintenance Service Contract will be subject to the satisfaction of the Medical Superintendent and may be terminated at any time along with written reasonable justification (in case of premature termination of the contract).
13. It may be noted that in case there is any complaint against services of the company during the CMC Period, the contract / repair order will be liable to be terminated with immediate effect.
14. Repairing should be done in the hospital premises as far as possible and in case it is not possible to repair in the hospital premises then proper permission from authorities is to be taken. Transport charges will have to be borne by the company if the equipment is to be transported outside the premises.
15. If the item is irreparable, then it should be brought to the notice immediately along with the certificate of irreparability with appropriate reasons.
16. The payment will be made half yearly after obtaining satisfactory services/report from the user department/ward/unit.
17. Bill to be submitted along with satisfactory services/report signed by the Head of the concerned unit /user department/ ward.
18. If original PMS reports duly authenticated by HOD (sign and seal) of the corresponding period as per work order are not submitted along with the bills, then the deduction would be done accordingly.
19. Shifting/ Reinstallation of equipment which are under AMC/ CMC is not included in the scope of contract.
20. Performance Security- 5% of the total cost of CMC/ AMC will be submitted as performance security at the time of acceptance in the form of Bank Guarantee/ FDR.
21. In case of any dispute, the parties shall make every effort to resolve the same amicably by mutual consultation. If both parties fail to resolve, then such dispute shall be referred to an Arbitrator appointed by both the parties mutually as per the arbitration and conciliation Act 1996 of India. Venue of such arbitration shall be Delhi.
22. For any physical damage due to the negligence of the CMC provider, the CMC provider shall be liable to bear all the repair/replacement cost of the parts and equipment.
23. Firms should submit a CMC renewal proposal before 03 months of expiry of the current CMC with escalation of CMC rates within reasonable limits, until the End of life certificate/Condemnation is proposed.
24. This CMC shall be governed by laws of India and in case of any dispute the courts in Delhi shall have the jurisdiction.
25. CMC contract is automatically stand cancelled if new MRI machine is installed in between CMC contract period with a prior notice of 15 days.
26. CMC will be taken without Helium gas refilling.

The Buyer ,is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid.All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM.If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.

13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller.
