The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

6. Buyer Added Bid Specific ATC

The Item to be supplied complying all the parameters and requirements as indicated in the Technical Scope of Work & Compliance sheet which is attached herewith this bid. Supply Subject to inspection and acceptance of Equipment at Buyer's site.

In the event of an order, 100% payment will be made within 45 days of receipt, acceptance of Installation and commissioning of Equipment/s by RTGS or any other latest Electronic Payment remittance mode.

Standard warranty of 12 months from the date of acceptance of items at HAL. Supplier shall be responsible for defects arising due to faulty materials, design, or workmanship, and shall remedy such defects at their own cost when notified by HAL. Replacement or renewal of defective portions shall be carried out without extra cost to HAL. During warranty, minimum uptime of 95% must be ensured; failing which, the warranty period shall be proportionately extended. Equipment shall be repaired/replaced free of cost during warranty, including any to & fro freight/insurance involved.

Liquidated Damages: If the Seller fails to deliver any or all of the Goods/Services within the original Delivery period specified in the Contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, @ 0.5 % per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value.

Supply of new / replacement goods. Any Customs duty, taxes & other charges involved for replacement goods etc.... has to be borne by Seller only. Such amount will be recovered from pending bills (of any division of HAL) / Seller has to transfer such specified amount as per HAL intimation to HAL designated bank account within specified time limits, failing which appropriate action as deemed fit shall be taken by HAL without further notice.

In case of rejections and return, the supplier has to bear the cost of transportation including return of rejected goods and the rejected goods have to be collected back from HAL premises / arrangements to be made by Seller with proper authorization.

As part of ISO45001:2018, HAL insists the Seller to comply with all the applicable Health and safety laws and regulations as per Indian factories act-1948.

As part of ISO14001:2015, HAL insists the Seller to comply with all the applicable Environmental laws and regulations as a minimum to Pollution control board requirements as applicable. The Seller or third interested party should make efforts to adhere to the Environment, Health and Safety (EHS) requirements as per applicable standards.

HAL, its Customers and Regulatory Authorities have the right to access Seller's manufacturing facilities or of Seller's sub-contractors and verify the processes with respect to ordered materials and related record with respect to QMS adopted to contract the manufacturing process.

Order is governed by GeM Terms and Conditions of Contract. In case of ambiguity, the additional terms and conditions of the bid document shall prevail.
