The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. 1. **DELIVERY PERIOD & LD CHARGES:** The items should be delivered within 45 days from the date of issue of the Contract Order. If the items are not supplied within the stipulated period of 45 days, liquidated damages (LD) @ 0.5% per week or part thereof, subject to a maximum of 10% of the actual total cost of the supplied items, shall be deducted from the final payment.
2. **LD CHARGES DURING WARRANTY PERIOD:** -If the firm fails to rectify any manufacturing defect during the warranty period within 15 days of prior intimation/request from the user end, LD charges shall be applicable @ 0.5% per week, subject to a maximum of 2% of the total Performance Guarantee (PG) amount. If the LD charges exceed 2% of the PG amount, the Performance Security Deposit of the firm shall be forfeited to the Government account.
3. **Performance Security:** - Successful bidders shall submit Performance Guarantee/Security Deposit @ 5% of total contract value in shape of account payee TDR, CDR/FDR from any commercial bank in favour of Superintendent of Police (CID) , A & N Police. The performance security shall be valid till the completion of 01 year plus 60 days beyond the completion of contract period. The performance guarantee will be released after completion of all contractual obligations.
