- TAXES:** The Firm shall specify GST applicable for all the items mentioned in above table & also submit price break-up during submission of offer.
- HSN Codes:** Firm shall specify HSN Codes applicable for all the items mentioned in above table.
- TERMS OF PAYMENT:** 100% payment plus taxes shall be paid through RTGS against Tax Invoice after receipt and successful inspection of material at Central Store, HTPS, Kasimpur subject to prior submission of the security deposit.
