7. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. ADDITIONAL TERMS AND CONDITIONS ENGAGEMENT OF MANPOWER IN J.N.V.

1. All existing manpower engaged in JNV/NVS on a daily wage basis/ suggested by JNV Principal/NVS will be given preference in engagement if or otherwise found suitable. The Agency has to agree that in selecting the Personnel to be deployed, it shall give preference to the Personnel having experience in a fully residential educational system on said work. In case of any dispute of opinion between JNV/NVS V/s Bidder the decision of JNV Principal/NVS will be final & binding.

2. Nos. of personnel may be increased or decreased in any category as per the need of the JNV/NVS. During the period of vacation or due to any administrative decision of the department, if any manpower is not retained by the JNV/NVS or the number of manpower is decided to reduce, the wages of such manpower will not be paid.

3. JNV/NVS are co-educational residential schools where the behavior of personnel plays a vital role. Personnel engaged should behave properly and maintain a high level of character attributes. It shall be the duty of the Agency to ensure that the deployed personnel shall conduct themselves in the most disciplined manner and in accordance with the Code of Conduct. The agency shall be directly held liable for any acts of indiscipline of the Personnel. In the event, JNV/NVS suffers any loss or damage on account of negligence, default, willful misconduct, or theft on the part of any of the deployed personnel, the Agency shall be liable to indemnify JNV/NVS for the same.

4. The persons deployed by the Contract agency shall be directly under the supervision, control, and employment of the Contractor. 6. The persons engaged shall not be below the age of 18 years and above the age of 45 years and they shall not interfere with the duties of the employees of the JNV/NVS. Relaxation in academic qualification and age can be considered only by the Vidyalaya as per requirement.
