2. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. i. PQR 1.1 - The bidder should submit the copy of purchase order and corresponding Material acceptance report/ Inspection cum Receipt Report/Goods Receipt Report/ Completion Certificate from the purchaser.

ii. Copy of valid certificates/licences are to be attested by Notary public or Gazetted officer or Practicing Chartered Accountant in Original.

b. The bidder shall be a Proprietary firm/Partnership firm/ a firm (Private, public, Govt) registered under Company's act.

c. The bidder should meet the criteria specified in PQR Clause 1.1.

d. The value stipulated in PQR is excluding GST/Service Taxes.

e. Conditions w.r.t Partnership Firms:

i. In case of bid submitted by any partnership firm, the pre-qualification work experience of partnership firm/any of the partners of the firm shall be considered for evaluation.

ii.
