2. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. QUALITY ASSURANCE

It is the responsibility of the Contractor to ensure compliance with the Quality Assurance requirement stipulated in the Tender document. For this purpose, the Contractor shall have appropriate Quality Assurance organization and have personnel with requisite qualification. The Quality System / Quality Assurance Manual of the contractor will be reviewed by the Purchaser/BHAVINI or its authorized representative for compliance with the Quality Assurance requirements specified in the Tender document.

All works covered by this tender/purchase order/work order shall be subject to Quality Surveillance by the Purchaser/BHAVINI or its authorized representative. All quality related activities will also be subjected to periodic Quality Assurance Audit by the Purchaser/BHAVINI or its authorized representative. The Contractor shall provide all required assistance by way of access at all reasonable times, necessary gauges, tools/tackles, fixtures, etc, for this purpose.

Quality Surveillance by the Purchaser/BHAVINI or its authorized representative shall not relieve the Contractor from the responsibility of meeting the specification or the inspection duties.

The inspection shall be in compliance with Quality Assurance Plan (QAP) prepared by the Contractor and approved by the Purchaser/BHAVINI. However, depending on the manufacturing procedure, quality assurance system of the company and manufacturing/inspection facilities available with the contractor, some additional checks may also be necessary, over and above the approved QAP. Such checks shall be incorporated and implemented by the Contractor without any extra financial implication to the Purchaser/BHAVINI.

The stores shall be dispatched only after the same are cleared by the Purchaser/BHAVINI or its representative nominated for this purpose and Shipping Release as per the prescribed format is obtained in writing.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its

outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove;**

and

- All operative provisions of the erstwhile Labour Laws until their complete substitution.

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
