Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

2. Department of Expenditure vide OM No.F.1/1/2022-PPD Dated.02/02/2022 has notified amendment to the rule / para 170 (i) of the GFR 2017 regarding Bid Security and Performance Guarantee. According to the amendment, Insurance Surety Bonds are also acceptable form of security in addition to the existing acceptable security in the form of Bank Guarantee from a commercial bank / account payee DD / FD Receipt from a commercial bank / Banker's cheque.

3. Documents not submitted along with the bid and clarifications sought during evaluation stage, but subsequently being submitted during representation shall not be considered for evaluation.

4. GeM GTC stipulates "One bid per bidder" condition under clause No.29. To ensure compliance to this clause, a declaration as per Annexure- II may be submitted along with the bid.
