Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local

content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 2. MAKE IN INDIA Declaration:

'Make in India certificate '(ANNEXURE-XI) In line with 'make in India' policy of Govt. of India, bidders are required to upload a declaration/certificate to this effect (as per our Annexure-XI format below in buyer added bid specific ATC document) along with the offer.

3. Item Acceptance Criteria:

a) In case of placement of order, the supplier shall initially supply 1 no. of collet chuck. The items will be checked for its performance by installing the same on light duty lathe machine. During the performance testing (2 days for 2 shifts), the collet chuck should not create a defect/dent on the work-piece being clamped. After satisfactory performance of the supplied sample, supplier can make bulk supply of remaining items.

b) After the bulk supply of items, the supplied quantity will be checked for performance by installing them on a light-duty lathe machine. During the performance testing (conducted over 1 day for 1 shift), the collet chuck must not create any defects or dents on the clamped work piece. Any deviation will lead to the rejection of the collet chuck.

c) The supplier shall submit material test certificate from NABL accredited laboratory for chemical composition and hardness. Supplier shall also submit a dimensional test report for each collet chuck. The test certificates or report shall meet the specification mentioned above.

d) Collets chuck shall free from any defects like dent, cracks or dimensional issues.

4. Vendor's Evaluation Criteria:

The bidder shall submit documentary evidence purchase order copy and its delivery challan or invoice or consignee receipt of previous supply of clamping devices/chuck in last 10 years, otherwise its offer will be rejected.

5. Note: Entire quantity shall be supplied in single lot only.

6. Delivery Instructions:

1) Delivery Timings & Working Hours:

a) NFC, Hyderabad works for 6 days in a Week (Every Sunday & Second Monday are holidays).

b) Material delivery can be accepted only in working days (Monday-Saturday, excluding Public Holidays) **between 09:00 Hrs., to 15:00 Hrs.**

If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
