Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

Scope of Work

Comprehensive Annual Service and Maintenance Contract for Lift Systems

This Scope of Work outlines the comprehensive responsibilities under the Comprehensive Annual Service and Maintenance

Contract (CAMC) of 13 Nos. Schindler Make Lifts installed at IIT Roorkee Campus. The contract ensures the safe, reliable,

and efficient operation of lift systems through preventive maintenance, emergency breakdown response, and timely repair

services. The contract shall exclude maintenance of lift car lighting fittings, fans, car doors, and batteries, which will remain

outside the purview of this agreement.

1. Preventive Maintenance Services

Considering IS 14665, 14671, 1578 & relevant applicable state rules, the concerned firm will perform the regular inspection

and preventive maintenance. This comprises:

- a) Monthly inspection and servicing of all Electromechanical and control components of the lift system.
- b) Lubrication of moving parts and cleaning of control panels and drive systems.
- c) Inspection and adjustment of braking system, control wiring, and mechanical assemblies.
- d) Testing of all safety devices and signaling equipment (including lift car lighting and fans).
- e) Maintaining logbooks and checklists for each service visit signed by authorized personnel.

2. Breakdown and Emergency Services

- a) 24x7 response to emergency breakdowns with response time not exceeding [4] hours.
- b) Prompt rectification of faults to minimize downtime and ensure passenger safety.
- c) Provision of standby support in case of prolonged repairs or unavailability of parts.

3. Repairs and Replacement

- a) Repair or replacement of non-functional components such as control switches, wiring, relays, and fuses.
- b) Minor spare parts and consumables to be provided by the contractor as part of the contract.

4. Safety and Compliance

- a) Ensuring the lift remains compliant with all applicable safety standards and government regulations.
- b) Coordinating inspections, annual audits, and obtaining fitness certifications as required.

5. Reporting and Documentation

- a) Monthly and quarterly service reports detailing maintenance activities and issues rectified.
- b) Emergency service logs with time of complaint, response, and resolution details.
- c) Maintenance checklist to be submitted after each visit with appropriate authorization.
- d) Bidder shall arrange annual safety verification of complete lift including ropes from OEM.
- e) Bidder shall provide any documents asked by Govt./ Local bodies w.r.t. applicable rules and for the proper operation of lifts.
- f) Bidder shall arrange quarterly emergency mock drills for the awareness of users in co-ordination with PI/ EIC.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.

However in case if any condition specified in सामान्य नियम और शर्तें/General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
