1. Generic

OPTION CLAUSE 25% : The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 25 percent with the consent of the service provider

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

Additional Terms to the GEM Inbuilt conditions: -

The period of the contract by the Department with the Service Provider shall be initially for a period of one year from the date of the award of the contract and can further be extended for one year provided that the performance of Service Provider is found satisfactory by the Department which is further subject to terms and conditions mutually agreed upon in writing.

The Service Provider shall engage a Contact Person/nodal official for coordination of the day-to-day activities of the service persons/manpower provided by the Service Provider and coordinating with the Department. He should be able to maintain and upkeep all the records pertaining to the job and accessible to the department at all times during the period of the contract.

Seeking any deposits or security amounts and registration fee from the deployed resources/manpower or any other form of monetary acceptance by the Service Provider is strictly prohibited. If any such complaint is received, incident will be raised on GeM portal for suitable action against the Service Provider, as per incident Management policy GeM. In addition, Department may separately initiate suitable penal action and blacklist the Service Provider as per the Blacklisting policy of UT Chandigarh Administration, "Policy on Blacklisting, 2009".

The Service Provider shall pay wages to the outsource employees/manpower on their own on or before 07th of every month and raise a bill for reimbursement with the department alongwith due evidence of salary and statutory dues payment (EPF, ESI etc.) in the form of a Utilization Certificate along with the bank statement confirming that all statutory compliances have been complied with.

The Service Provider/bidder should not have been blacklisted/prosecuted by any Central/State Government/Union Territories/Department/Offices/Statutory Bodies/Autonomous Organizations/Research Institution/any court of law and the service provider/bidder should not be under liquidation, court receivership or any similar pending proceedings. The Service Provider must furnish a valid affidavit which must be prepared between the date of opening and closing of the Tender on GEM Portal and same must be executed on non-judicial stamp paper duly attested by the Notary/Executive Magistrate regarding non blacklisting/non prosecution of the Service Provider as per Performa given below:-

6. The bidder(s) shall provide copies of GST and PAN No(s) while uploading their bid on the GEM portal ;

7. MSME's / startup in the relevant field shall be allowed applicable exemptions under the applicable rules;

8. Any amount due and recoverable from the Service Provider on account of salary/wages (minimum wage, insurance, PF, ESI etc.) and taxes will be recoverable from the bank/ePBG or as arrears of land revenue.

9. If the Service Provider fails/delays in performance of any of the obligations under the Contract/violates any of the provisions of the Contract/commits breach of any of the terms and conditions, the Department may at any time, without prejudice to any other right of action/remedy, may blacklist the Service provider under the Blacklisting policy of UT Chandigarh Administration, "Policy on Blacklisting, 2009 dated the 27th February 2009".

11. The successful bidder/contractor shall be required to absorb and continue the engagement of additional existing these (11) employees, namely One (1) Law Officer, One (1) Steno Typist, One (1) Data Entry Operator, Three (03) Clerks and Five (05) Multi-Tasking Staff (MTS), who are presently engaged through the existing Service Provider up to 14.09.2026. Upon expiry of the said period, i.e. with effect from 15.09.2026, the successful Service Provider shall take over the engagement of these employees without any break or interruption in their services, subject to their willingness and satisfactory performance, and in accordance with the applicable labour laws and the terms and conditions of the contract. Hence, tender will be allotted for four manpower (4).

18. These (11) employees, namely One (1) Law Officer, One (1) Steno Typist, One (1) Data Entry Operator, Three (03) Clerks and Five (05) Multi-Tasking Staff (MTS), who are presently engaged through the existing service provider, will not count under 25% increase or decrease allowed by the GeM Portal.

19. In case of any replacement/new requirement of manpower, a panel of three persons against 01 post will be sent by the Successful bidder/service provider along with requisite documents for making selection.

20. The rate of Admin charges shall be charged on existing DC rates applicable in the UT of Chandigarh. In the event of any revision in minimum wages, DC rates, or other statutory wage components during the contract period, only the differential wage amount shall be paid to the Service Provider.
