If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in

respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for % (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

2. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

#### 1. Generic

OPTION CLAUSE 25% : The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 25 percent with the consent of the service provider

#### 2. Buyer Added Bid Specific ATC

1. FOR DETAILED SCOPE OF WORK AGAINST INDIVIDUAL SOR, BIDDER TO REFER SECTION V - SPECIAL CONDITIONS OF CONTRACT & SCOPE OF WORK OF TENDER

2. BIDDERS SHALL SUBMIT A DETAILED PRICE BREAKUP SHEET INDICATING ITEM-WISE PRICES CORRESPONDING TO THE SOR. FORMAT FOR PRICE SCHEDULE/ SCHEDULE OF RATE IS ATTACHED WITH GEM BID DOCUMENT. THE SUM TOTAL OF THE PRICE BREAKUP SHEET SHOULD BE EQUAL TO THE LUMP SUM PRICE QUOTED ON THE GEM PORTAL. .

3. THE LUMP SUM PRICE QUOTED ON THE GEM PORTAL SHALL BE CONSIDERED AS THE FINAL EVALUATED PRICE FOR THE PURPOSE OF RANKING (L1 DETERMINATION).

4. IN CASE OF ANY MISMATCH BETWEEN THE LUMP SUM PRICE QUOTED ON GEM AND THE TOTAL AMOUNT APPEARING IN THE PRICE BREAKUP SHEET SUBMITTED BY THE L1 BIDDER, THE FOLLOWING METHODOLOGY SHALL BE ADOPTED:

SCENARIO 1: IF THE LUMP SUM PRICE QUOTED ON GEM IS HIGHER THAN THE TOTAL AMOUNT MENTIONED IN THE PRICE BREAKUP SHEET, THE LOWER VALUE (I.E. TOTAL OF BREAKUP SHEET) SHALL BE CONSIDERED FOR AWARD OF JOB. THE PRICES AS PROVIDED IN THE BREAKUP SHEET SHALL BE RETAINED. ACCORDINGLY, THE BIDDER SHALL BE REQUIRED TO REVISE THE LUMP SUM PRICE ON THE GEM PORTAL (AFTER EXERCISING NEGOTIATION TAB ON GEM PORTAL) TO ALIGN WITH THE TOTAL OF THE PRICE BREAKUP SHEET FOR THE PURPOSE OF AWARD OF CONTRACT.

SCENARIO 2: IF THE LUMP SUM PRICE QUOTED ON GEM IS LOWER THAN THE TOTAL AMOUNT MENTIONED IN THE PRICE BREAKUP SHEET, THE LUMP SUM PRICE QUOTED ON GEM SHALL BE CONSIDERED FOR AWARD OF CONTRACT. IN SUCH CASES, % VARIATION SHALL BE ADJUSTED BY UNIFORMLY DISTRIBUTING TO ALL THE SOR ITEMS TO ENSURE MATCHING WITH THE TOTAL QUOTED LUMP SUM PRICE AT GEM PORTAL.

5. BIDDERS ARE ADVISED TO ENSURE CONSISTENCY BETWEEN THE LUMP SUM PRICE QUOTED ON GEM AND THE SUBMITTED BREAKUP SHEET. ANY DISCREPANCY SHALL BE DEALT WITH AS PER THE PROVISIONS ABOVE, AND NO POST-BID CORRECTION REQUESTS SHALL BE ENTERTAINED.

## अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents (other than EMD and signed Integrity Pact - which can be submitted within 5 days of bid opening) in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. 13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्यवाई का आधार होगा।/In terms

of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
