1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

3. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within $L-1+ 15\%$ (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. 5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 80% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

4. Warranty

Warranty period of the supplied products shall be as given in specifications from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Purpose: Integrated laboratory system for determination of wet gluten, gluten index and dry gluten in wheat and flour-based samples, with provision for wholemeal/ meal and vital gluten analysis.

Parameter / Requirement Minimum general specification

1. Sample types Wheat meal, wheat flour, durum meal, semolina, durum flour and vital wheat gluten; suitable for both flour and wholemeal/meal samples.
2. Parameters Wet Gluten Content, Gluten Index, Dry Gluten Content and gluten water-binding/moisture-related correction where applicable.
3. Gluten washing unit Integrated washer with two or more test positions/chambers for simultaneous processing of two samples, with programmable kneading and washing cycles.
4. Kneading/washing control Timer-controlled operation; cycle duration adjustable in seconds/minutes to accommodate different sample types. Typical total test time 10 minutes or less for conventional wet-gluten workflow.
5. Washing accessories Wash chambers, collection cups (≥ 500 mL, minimum 2 nos.), fine sieves around $88 \pm 2 \mu\text{m}$ for flour and coarse sieves around $840 \pm 5 \mu\text{m}$ for meal/wholemeal, wash containers (≥ 10 L, minimum 2 nos.), tubing, dispensers and wash bottles, complete with required fittings.
6. User interface Touch-screen display, preferably ≥ 5 inch, showing sample identification, date/time, operating status and relevant test conditions. Start/stop, pause and reset functions should be available during operation.
7. Sample identification & results Provision for entering sample names/IDs before analysis should be there. Automatic calculation, display and storage of results; repeat-test averaging should be possible. Result output/printing or electronic export should include sample ID and test information.
8. Gluten Index / centrifugation Integrated or compatible regulated high-speed centrifuge with safety locking lid and two or more test cassettes/containers for Gluten Index determination; operation at 5000-7000 rpm for the standard test duration.
9. Dry-gluten determination Integrated or compatible gluten dryer capable of drying gluten to obtain dry-gluten value within approximately 3-4 minutes, with controlled heating and automatic/visual indication of test completion.
10. Standards / methods The system shall comply with or support recognized methods including ICC 137/1, ICC 155, ICC 158, ISO 21415 and AACC 38-12, as applicable to the parameters offered.
11. Data connectivity USB and Ethernet or equivalent interfaces for data transfer; software should permit result storage/export and, where available, integration with laboratory data systems.
12. Power supply Suitable for standard Indian power supply or compatible universal input; supplier shall provide

provide all necessary power and connection accessories. The system should be able to operate properly under all North Indian climate conditions.

13. Operating conditions Suitable for laboratory operation at room temperature and 30-90% relative humidity, non-condensing, or better.

14. Safety Appropriate electrical and operational safety features, including interlocks/locking covers for centrifugation and thermal protection for drying unit.

15. Accessories & spares All standard accessories required for immediate operation shall be supplied. Essential spare fuses and other routine consumables/accessories required for operation shall be included.

16. Software & documentation Instrument control/result-processing software to be supplied with the system. User and service manuals shall be provided in hard and soft copy.

17. Warranty & support Minimum 3-year comprehensive warranty. Availability of software support, essential accessories and spares for at least 10 years.

18. Installation On-site installation, commissioning, operational demonstration and basic user training shall be provided free of cost.

19. UPS Compatible online UPS of suitable capacity for 60 minutes for the system shall be provided/ recommended by the supplier.

20. User certificate Minimum three user certificates in India of reputed govt institutes/ industry.

21. If the bidder is not OEM, the bidder shall submit Bid Specific Manufacturer Authorization Certification from OEM against this bid.

Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller.
