Liquidated damages for delayed supply (Bidder must be submitting self-declaration on letter head): If vendor fails to deliver any of or all products or does not perform the services within the period specified in the contract, the buyer reserves the right to, without prejudice to its other remedies under the contract, deduct from the bill, a sum equivalent to 1% of the price of undelivered stores at the agreed price for each week to a maximum limit of 10% of the value of stores so undelivered. Once maximum is reached, the buyer may consider termination of contract and forfeiture of bid security.

Affidavit: The Bidder shall furnish an affidavit on e-Stamp paper duly notarized having value of INR 100 to the effect that the correct information has been furnished in the Tender and the Bidder shall be solely responsible for furnishing wrong/false information in the Bid. The Tender Number, Date, must be clearly mentioned in the affidavit. The Bid will be rejected without this document. Please note that the original documents must be submitted to the office prior to the bid closure deadline.

The bidder must have to submit an acceptance on INR 100 Non-Judicial Stamp duly notarized that there will be no objection taken from any bidder for this tender for qualify and disqualify to any bidder. The Decision Bid authority is final decision for technical qualify or disqualify any bidder from this BID. The Bid Will Be Rejected without This Document. Please note that the original documents must be submitted to the office prior to the bid closure deadline.

EMD exemption will be allowed as per Madhya Pradesh Store Purchase Rules and MSME guidelines; the bidder shall be liable for any false or misleading documents.

OEM must be submitting a self-declaration for manufacturer with evidence documents.

General information of the bidder form must be submitted on company letter head with complete detail of company/ firm proprietor, partner, director contact no and address.

Bidder needs to upload declaration of GST of product.

Prices shall be inclusive of all temporary permits, freight, insurance and all such other costs. Prices shall remain firm and no escalation shall be permissible. All statutory taxes and duties as applicable, within India shall be paid by the Supplier. For supply of Machines of foreign origin, the supplier shall also arrange for customs clearance, port handling and inland transportation/ insurance of the machines from Port to the consignee place. Undertaking must be submitted on letter head.

Any suppression, misrepresentation, or deviation found at any stage shall render the bidder liable for action by the competent authority, including rejection of the bid. Bidder must be submit a declaration for the provide Service Support within 24hr on the date of complaint during the warranty period. If not fulfil this condition the buyer will charge penalty as per LD Charge norms.

All products and accessories should be of good quality. In case the quality of the product is bad & poor, the entire material will be rejected and the full responsibility will be on the bidder. Undertaking must be submitted by bidder in ATC.

Special Conditions

1. The bidder shall carefully examine the attached item list/BOQ and quote a single consolidated (lump-sum) rate for the supply of all items mentioned therein. The quoted rate shall be deemed to include all costs associated with the supply of the listed items.

2. At the time of submission of the invoice/bill, the successful bidder shall provide a detailed item-wise breakup indicating the description of each item, quantity, unit rate, and total amount. The aggregate of all item-wise amounts shall be in conformity with the accepted bid value.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा |/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
