1. **Buyer Added Bid Specific ATC**

Terms and Conditions for Hiring of Vehicle under MTM programme

1. The vehicle is proposed to be hired for **implementation of the MTM (Makalai Thedi Maruthuvam) Scheme at Kandhili Block, Tirupathur HUD.**
2. The vehicle offered shall **not be more than four (4) years old** from the original date of registration as on the date of commencement of contract.
3. The vehicle shall be a **commercially registered vehicle** and shall **not have run more than 1,00,000 (One Lakh) kilometres** at the time of award of contract and during the contract period.
4. In the event of the vehicle completing **1,00,000 kilometres during the contract period**, the vendor shall **replace it with another vehicle having less than 1,00,000 kilometres**, without any additional cost to the Department.
5. SUV / Sedan vehicles meeting all bid conditions shall be treated at par with hatchback vehicles for the purpose of this bid.
6. The hired vehicle shall be **parked at the Kandhili Block Office** or at any location specified by the Block Medical Officer.

Documents to be Uploaded for Technical Evaluation

The bidder shall upload the following documents for technical evaluation:

1. Vehicle Registration Certificate (RC)
 2. Valid Comprehensive Insurance Certificate (covering third party liability and occupants).
 3. Valid Permit Certificate
 4. Pollution Under Control (PUC) Certificate
 5. UDYAM Registration Certificate (if applicable)
 6. Aadhaar Card of the Vehicle Owner
 7. PAN Card of the Vehicle Owner / Agency
 8. Driving Licence of the Driver along with Aadhaar Card
7. All the above documents shall be **produced in original for verification** after award of the bid and **before execution of the agreement.**
 8. If **any discrepancy, falsification, or mismatch** is found in the submitted documents **at any stage during or after execution of the agreement**, the contract shall be **liable for cancellation without any notice.**

9. The responsibility for **ESI, EPF, wages, statutory compliances, and all labour-related obligations of the driver** shall rest solely with the **vehicle owner/vendor**.
10. **Both Technical and Financial Evaluation scores** shall be considered for finalisation of the bid, in order to ensure **quality and reliable service delivery**.
11. In case of any dispute arising out of this contract, the **decision of the District Health Society, Tirupathur**, shall be **final and binding**.
12. The seller/vendor shall comply with all **rules, regulations, instructions, and guidelines** issued by the **District Health Officer / District Health Society** from time to time.
13. Upon successful selection through bidding, the seller/vendor shall **enter into a legally binding contract** with the **Block Medical Officer**, as per the **existing terms and conditions** of the Department.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents (other than EMD and signed Integrity Pact - which can be submitted within 5 days of bid opening) in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.
